**Staff Summary:** This code amendment will modify the City's existing sign code by adding a section for new automobile dealerships and their signage needs. The code addresses an overall signage maximum, building's signs, freestanding signs, number, height and size, secondary signs and other permitted uses such as pennants, large inflatable devices, balloons, banners and changeable and directional signs; as well as administrative variances.
