SUBJECT: Selection of Planning Commission meeting date for November 2011

Recommended Motion: "I move to hold the November 2011 Planning Commission meeting on November _[16 or 30]_, and accept the 2011 Planning Commission meeting schedule."

Discussion:

The Planning Commission bylaws require the Planning Commission to meet on the last Wednesday of each month, except that the Commission may hold the meeting the week prior to the holidays in November and December. The last Wednesday in November 2011, November 30th, falls after the Thanksgiving holiday. The Planning Commission may elect to hold the meeting on this date or choose to hold the meeting before the Thanksgiving holiday, on November 16.

Staff has no preference on which date the meeting is held. However, it should be noted that if the meeting were to be held on November 16, it would have to start earlier in the afternoon because of an Airport Authority meeting conflict at 6:30 in the Sierra Room. The Planning Commission meeting could be held at its regular time of 5:00 p.m. on November 30.

The December 2011 meeting will be held on the 21st, the week before the Christmas holiday.
