AUTHORITY: Article 1, Sec. 1.080 of the Carson City Charter establishes the Carson City Charter (Review) Committee as outlined below:

1. The candidates for membership on the charter committee must be nominated as follows:
 - a. Each supervisor shall nominate atleast one candidate; and
 - b. Each member of the senate and assembly delegation representing the residents of the city shall nominate at least one candidate.
2. The board shall:
 - a. Determine the appropriate number of members of the charter committee from the candidates nominated; and
 - b. Appoint the members of the charter committee.
3. Each member of the charter committee must:
 - a. Be a registered voter in Carson City;
 - b. Serve a term concurrent to the term of the public officer by whom he was nominated;
 - c. Reside in Carson City during his term of office; and
 - d. Serve without compensation.

MEETINGS: Meet at least once every 2 years before the beginning of each regular session of the legislature and when requested by the board or the chairman of the committee.

Meet jointly with the board on a date set after the final biennial meeting of the committee is conducted pursuant to Subsection 2 and before the beginning of the next regular session of the legislature to advise the board with regard to the recommendations of the committee concerning necessary amendments to this charter.

PURPOSE: To assist the board in the timely preparation of such amendments for presentation to the legislature on behalf of the city.
