A meeting of the Carson City Liquor and Entertainment Board was held during the regularly scheduled Board of Supervisors session on Thursday, August 4, 2005, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, that began at 8:30 a.m.

Mayor Pro-Tem Williamson recessed the Board of Supervisors and immediately convened the Liquor and Entertainment Board by noting that there was a quorum present. Chairperson Marv Teixeira was absent. Member Furlong was present. For Minutes of the Board of Supervisors, see its folder for this date.

**A. ACTION TO APPROVE MINUTES OF NOVEMBER 4, 2004, AND JUNE 2, 2005 (1-0100) -** Member Livermore moved for approval of the Minutes of the Liquor and Entertainment Board for November 4, 2004, and June 2, 2005, as presented. Member Aldean seconded the motion. Motion carried 5-0.

**C. ACTION TO APPROVE A PACKAGED LIQUOR LICENSE FOR WAL-MART STORES, INC., DBA WAL-MART SUPERCENTER #3408, LOCATED AT 3200 MARKET STREET, WITH PHILLIPSCOTT YODER AS LIQUOR MANAGER (1-0111)-** City Manager Linda Ritter, Phillip Yoder - Mr. Yoder indicated that he is familiar with the liquor laws and would not serve minors. Wal-mart has an extensive training program at the store. He intends to be on site quite often. Discussion indicated that the new store will be on October 26. They are now in the process of hiring employees. All employees and associates will attend the training program. Member Furlong indicated that the Sheriff's investigation had been completed without finding any concerns. Discussion indicated that Mr. Yoder did not, to his knowledge, have any relatives living in Fallon. He does have relatives living in Northern California. Member Livermore advised Mr. Yoder that the Sheriff's Office does, from time to time, conduct sting operations and that he was

certain occasional stings would be conducted at Wal-mart. He suggested that the employees be informed about the substantial penalties for selling to minors. Mr. Yoder indicated that his firm also conducts in-house sting operations. Member Livermore moved to approve a packaged liquor license for Wal-mart Stores, Inc., DBA Wal-Mart Supercenter #3408, located at 6200 (3200) Market Street, Carson City, with Phillip Scott Yoder as Liquor Manager; fiscal impact is \$1,000 original new fee, \$500 investigation fee, and \$200 quarterly fee. Member Aldean seconded the motion. Motion carried 5-0. Vice Chairperson Williamson welcomed him to the community and wished him success.

**B. ACTION TO APPROVE A BEER AND WINE LICENSE FOR LUZ RAMIREZ-GARCIA, DBA MARIACHI LOCO DE AMECA, LOCATED AT 577 SOUTH SALIMAN ROAD (1-0166) -** Luz Ramirez-Garcia - Ms. Ramirez-Garcia indicated that she is the only store manager. She understood the liquor laws. She cannot serve minors. Her employees, who will be family members, know the liquor laws. Although she indicated she could read enough English to determine if the individual is a minor, she also advised that there will be someone present who can determine if an individual is a minor from his/her identification. Discussion indicated that they cannot serve liquor through the drive-up window. Ms. Ramirez-Garcia concurred. Member Furlong indicated that the Sheriff's Investigation had been completed and that the Sheriff's Office had no objections to her license. Mr. Kramer indicated that applicants are routinely informed that liquor cannot be sold through drive-up windows. Discussion explained the reasons for this prohibition including the Statute prohibiting having open containers in vehicles. Member Aldean moved to approve a beer and wine license for Luz Ramirez-Garcia, DBA Mariachi Loco De Ameca, located at 577 South Saliman Road, Carson City; fiscal impact is \$500 original new fee, \$500 investigation fee, and \$150 quarterly fee. Member Livermore seconded the motion. Motion carried 5-0.

**D. ACTION TO APPROVE A CHANGE IN LIQUOR LICENSE MANAGERS FOR LONGS DRUG STORES CALIFORNIA, INC. DBA LONGS DRUG STORE, LOCATED AT 3240 HWY 50 EAST, FROM ALAN POPE TO STEVEN MCCANN (1-0230) -** Steven McCann explained that Mr. Pope no longer works for Longs. Mr. McCann indicated that he is familiar with the liquor laws. Kathy Pierson, the store's manager, was present. Member Furlong advised that the Sheriff's investigation had been completed and found no problems. Public comments were solicited. None were given. Member Aldean moved to approve a change in liquor license managers for Longs Drug Stores California, Inc., DBA Longs Drug Store, located at 3240 Highway 50 East, from Alan Pope to Steven McCann; fiscal impact is \$75 investigation fee. Member Livermore seconded the motion. Motion carried 5-0.

There being no other matters for consideration as the Liquor and Entertainment Board, Vice Chairperson Williamson adjourned the Liquor and Entertainment Board.
