






Under Zoning Review

- Scheduled for Planning Commission meeting on October 28.





- Scheduled for Planning Commission meeting on October 28.






- Scheduled for Planning Commission meeting on October 28.







- Approved by Planning Commission on September 30, 2015.





- Approved by Planning Commission on September 30, 2015.





- Approved May 27, 2015; pending recordation of final map.






Figure 5 – Preliminary Site Plan




Approved Pending Building Permit

- Construction Valuation: \$2.4 million.




Under Building Permit Review
