

RELEASE OF LIABILITY AND WAIVER

The participant, their parent, guardian, or person with legal responsibility (collectively may be referred to as "Releasing Parties"), understands, acknowledges, and agrees, that: ice skating is an inherently dangerous and physically demanding activity. Releasing Parties assume full responsibility for any risk of injury, property damage, or death connected with the use of or authorization to participate in activities at this establishment. Releasing Parties hereby waive any and all claims including, but not limited to, bodily injury including death and property damage they may have against Carson City, Ice Rink Events, sponsors of the ice rink establishment, and all subsidiaries, affiliates, partners, officers, directors, employees, agents, and volunteers of each of the foregoing (collectively referred to as "Carson City") arising out of or connected with the Releasing Parties' use or authorization to use the ice skating rink and all surrounding areas.

Releasing Parties also release and hold harmless Carson City from any and all liability for any loss, damage, or expense that the Releasing Parties' heirs, next of kin, families, relatives, guardians, conservators, executors, administrators, trustees, assigns, and legal representatives may suffer as a result of Releasing Parties' use of or connected with the use of the ice skating rink, from any cause whatsoever, including but not limited to, negligence or breach of contract on the part of Carson City, in the operation, supervision, control, design, maintenance, condition of the ice surface or of the ice rink and all surrounding areas.

Releasing Parties agree that each person listed below will abide by the skater rules and regulations as posted within the ice rink or surrounding area for the use of the ice skating rink and will follow the instructions of the operating staff of the rink. Failure to follow these codes of conduct may result in the termination of the Releasing Parties' use of, or authorization to use, the ice skating rink, the surrounding areas, and any rental equipment, without refund. Releasing Parties permit Carson City to use any photographs, video or audio recordings, or any other records taken while on the ice skating rink premises for publicity, advertising, or any other legitimate purpose.

This release is intended to be construed as broadly and inclusively in favor of Carson City as permitted by law, and is intended to be effective and binding upon Releasing Parties' heirs, next of kin, families, relatives, guardians, conservators, executors, administrators, trustees, assigns, and legal representatives.
