For Possible Action: MEMORANDUM OF UNDERSTANDING FOR RECIPROCAL FISHING AND WATERCRAFT REGISTRATION REQUIREMENTS ON THE WATERS OF THE COLORADO RIVER IN COMMON TO THE STATES OF NEVADA AND ARIZONA - FISHERIES DIVISION ADMINISTRATOR JON SJÖBERG.** The commission may consider changes to the Memorandum of Understanding ("MOU") for the Reciprocal Fishing and Watercraft Registration Requirements on the Waters of the Colorado River in Common to the States of Nevada and Arizona, between the Nevada Department of Wildlife and the Arizona Game and Fish Department. The MOU currently identifies a requirement for Nevada anglers to possess a Colorado River Special Use

Stamp when fishing on common waters of the Colorado River or on the Arizona shoreline. That language is no longer needed as the Colorado River Special Use Stamp will be eliminated on January 1, 2018 as part of proposed Nevada fishing license changes.

**8-I. For Possible Action: COMMERCIAL COLLECTION OF REPTILES - DRAFT REGULATIONS FOR COMMISSION CONSIDERATION - WILDLIFE DIVERSITY ADMINISTRATOR JENNIFER NEWMARK.** The commission will consider at least two potential regulations for commercial collection of reptiles. One regulation could prohibit all collection of reptiles for commercial purposes, either temporarily or permanently. The other regulation could limit collection of reptiles for commercial purposes, based on season, species, collection area, and / or take. Options will be discussed and the commission may choose to direct the Department to advance a recommendation to a future commission meeting.

**8-J. For Possible Action: PRONGHORN ANTELOPE TRANSLOCATION - GAME DIVISION ADMINISTRATOR BRIAN F. WAKELING.** A request for up to 200 pronghorn has been received by the Department from the Yakama and Colville Tribes in Washington. The Department will provide an update on the status of Nevada's pronghorn population and potential source herds for translocations. The commission may approve the translocation requests for 2017 and 2018, as well as provide direction to the Department for fulfilling these requests.

- 9. 7. Informational Item: UPDATE AND ACTIVITY REPORT ON THE CARSON CITY URBAN WILDLIFE COMMITTEE

Chairperson Boehmer introduced the item. Vice Chair Martin referenced communication he had received from the Carson City Parks and Recreation Department regarding the hiring of an AmeriCorps volunteer who, among other duties, will handle urban wildlife issues, and will attend a future meeting of this Board. Vice Chair Martin also referenced material provided by him and incorporated into the record, titled "Living with Nevada's Urban Coyotes", and announced a seminar held by the Nevada Department of Wildlife (NDOW) in Reno on August 14, 2017. He announced the eighth annual wood duck event, flyer incorporated into the record, in Fallon on August 19, 2017. Vice Chair Martin also advised the public to be cautious of the urban deer in Carson City. Member Green noted that the deer are not just on the west side of the City, adding that they are in the Arrowhead Drive area as well.

Chairperson Boehmer cited several deer sighting near his home and another near the Lompa Lane area. He also referenced coyote signs provided by the City and urged the public to be careful. Member Yanuck reported that he had looked into the bear incidents near Carson Tahoe Health and explained that the hospital's vice president of operations had looked into the trash container issue and noted that the trash containers had been locked, and as a result, no incidents had been reported since.

8. Informational Item: REPORT ON ASH CANYON ACCESS TO HOBART RESERVOIR.

Chairperson Boehmer introduced the item and stated that he had received a report from Carson City Open Space Administrator Ann Bollinger who had indicated that "nothing had changed" regarding Ash Canyon, and that "they are waiting for the FEMA process...to be able to get the funding and to make those repairs".

NDOW Regional Outdoor Education Coordinator Dawn Baugh introduced herself and described two clinics she had held at Hobart Reservoir one of which transported disabled veterans via four-wheel drive vehicles, and the other was "a kids' event". She also stated that their website had been updated to notify users that the road had been closed and was only accessible via a keyed access. She clarified that "the Parks [Department] manages the road and we [NDOW] manage the water", adding that the Parks and Recreation Department, working with FEMA, estimated the roads to open in the fall of 2018. Chairperson Boehmer entertained public comments.

PUBLIC COMMENT

(4:22:47) – CK Baily praised Ms. Baugh calling her “a very good educator”. He also explained that the only way to reach Hobart Reservoir was by horse, bicycle, or on foot by hiking through Lakeview and Hobart Roads, which he believed left 89 percent of the fishing public out.

(4:28:51) – Kurt Zeilenga introduced himself as an avid fly fisherman who fishes at Hobart Reservoir when he can access it. He wished to see the road open as soon as possible and believed that the lake will not be stocked until access is available.

(4:30:25) – Vice Chair Martin noted that he “had heard enough from members of the public, and I know that other members of the public are also concerned about limited access this year”. He acknowledged that this Board could not take action to reopen the road; however, he believed that action should be taken in the future to encourage the opening of the road, since this item is informational only. He also believed that the “other access road” should be opened. Member Yanuck noted that when NDOW invites public help “to put fish in or take fish out”, many volunteer because they go in the NDOW trucks, adding that he has noticed many locks that belong to various agencies and did not know why the area was not open to the general public. Discussion ensued regarding the ownership of the road. Member Yanuck suggested bringing the item up at a future Board of Supervisors meeting for possible answers. Chairperson Boehmer believed it may be too late for this year; however, he was in favor of agendizing the item for the September meeting.

For Possible Action: COMMERCIAL REPTILE COLLECTION - WILDLIFE DIVERSITY ADMINISTRATOR JENNIFER NEWMARK.** *The Department will present the commission with background information regarding commercial collection of reptiles in Nevada, along with numerous potential alternatives for consideration. The commission may choose to provide direction to the Department regarding commercial collection of reptiles.*

**9-F. For Possible Action: BUREAU OF LAND MANAGEMENT PUBLIC LAND PARCEL DISPOSAL - HABITAT DIVISION ADMINISTRATOR ALAN JENNE.** *The commission will receive comment on maps depicting lands identified by the Bureau of Land Management as potentially suitable for disposal in BLM's existing Resource Management Plans across various BLM districts in Northern Nevada. WAKELING.** *The Department will provide an overview concerning the current Landowner Deer and Antelope Compensation Program, recent updates to statutes, share current practices, identify areas of necessary improvement, and provide a potential revision process for the Commission's consideration. The Commission may provide the Department with direction following consideration of this proposal.*

**10. For Possible Action: DISCUSSION REGARDING NON-REGULATORY AGENDA ITEMS AS PART OF THE AUGUST 11 AND 12, 2017 NEVADA BOARD OF WILDLIFE COMMISSIONERS MEETING.** *Other than those items listed under the CCABMW consent agenda (item 8 above), the remaining items on the attached August 11 and 12, 2017 Nevada Board of Wildlife Commissioners agenda typically require no action of the Carson City Advisory Board to Manage Wildlife. Occasionally, one or more advisory board members may have a desire to discuss these items and such discussion may result in action in the form of advice or a recommendation by this advisory board to the Nevada Board of Wildlife Commissioners. There will be no public comment unless action will be taken on an item.*

(4:40:51) – Chairperson Boehmer introduced the item. No items were presented for discussion. There were no public comments.

**11. For Possible Action: DISCUSSION AND POSSIBLE ACTION REGARDING ADVISORY BOARD MEMBER COMMITMENT(S) TO THE AUGUST 11 AND 12, 2017 WILDLIFE COMMISSION MEETING IN MINDEN AND THE SEPTEMBER 22 AND 23, 2017 WILDLIFE COMMISSION MEETING IN LAS VEGAS**

(4:41:48) – Chairperson Boehmer introduced the item and noted that he had a conflict and would be unable to attend the August 11 and 12, 2017 meeting in Minden and recommended that Board members attend the County Advisory Board Workshop if they can, since Mule Deer management, and the evaluation and review of landowner tags were going to be discussed during the workshop. Members Yanuck and Green they would attend the meeting and the workshops, and Vice Chair Martin stated he would be there on Saturday.

(4:44:03) – Chairperson Boehmer noted that Member Yanuck would attend the September 22 and 23, 2017 Commission meeting, adding that no video conferencing will be offered for that meeting.

**12. Informational Item: NEXT CCABMW MEETING.**

(4:45:08) – Chairperson Boehmer indicated that since the next meeting of the Nevada Board of Wildlife Commissioners is scheduled for September 22 and 23, 2017 (in Las Vegas), the next meeting of the Carson City Advisory Board to Manage Wildlife will be tentatively scheduled for Monday, September 18, 2017.

**13. Informational Item: FUTURE AGENDA ITEMS**

(4:46:25) – Chairperson Boehmer entertained suggestions. Vice Chair Martin requested a discussion on access to Hobart Reservoir through Ash Canyon. Member Green believed the discussion may be too late for this year; however, he was concerned that the road will not be open until fall 2018.

**14. PUBLIC COMMENT**

(4:47:30) – Chairperson Boehmer introduced the item. Mark Enders introduced himself as a wildlife biologist with NDOW in the Wildlife Diversity Division which is responsible for “managing the State’s non-consumptive wildlife resources”. Mr. Enders wished to make himself available to the Board and the public regarding item 9-G, pertaining to commercial reptile collection. Member Yanuck recounted a field trip during a Commission meeting to see unauthorized reptile traps, and was surprised by the worldwide commercialization of reptiles. Chairperson Boehmer noted that he agreed with the agenda item and that “it’s about time”. Both the Chair and Vice Chair expressed regret that they did not know Mr. Enders represented the Diversity Division, and did not call on him to speak earlier. Member Green was also disappointed by the amount of reptiles collected from Nevada and was pleased that the Commission will address the issue. Chairperson Boehmer thanked Mr. Enders.

(4:58:14) – Ms. Baugh noted that because of the closure this year, Hobart Reservoir will have much larger fish next year. She also invited instructors to assist with her programs and transport the children to the reservoir.

(4:59:02) – Fred Voltz wished to clarify some “misinformation going on regarding the hospital situation”, adding that as of a few days ago, the trash dumpsters were not locked. He was certain that locks on the enclosures versus the dumpsters were “not enough”. Mr. Voltz suggested having the AmeriCorps volunteers check the compliance of the commercial installations in the area. In response to a question by Member Yanuck, who noted that he had discussed the issue with the hospital’s vice president of operations, Mr. Voltz stated that cameras will not solve the problem. Member Green recounted past experiences indicating that video cameras will not solve the problem. Discussion ensued regarding other wildlife accessing the dumpsters. Chairperson Boehmer noted that he had discussed the issue with NDOW and Carson City Supervisor Karen Abowd who believed that Waste Management did not have locked containers as part of their contract with the City; however, she offered to discuss is with the Board of Supervisors.

**15. For Possible Action: ACTION ON ADJOURNMENT**

**(5:06:30) – Member Yanuck moved to adjourn. The motion was seconded by Member Green. The meeting was adjourned at 5:06 p.m.**
