During the September 2012 commission meeting, the Department presented a proposal and informational paper entitled, "Big Game Tag Applications Available Online-only Beginning in 2013." The informational paper is now augmented with an addendum which addresses the results of a survey sent to those applicants who have applied using only the paper application format during the last two years. The commission may take action to direct the Department to proceed with online-only tag applications beginning in 2013.
 - 10-B. For Possible Action: COMMISSION REGULATION 13-01 TAKING OF RAPTORS FOR FALCONRY FOR 2013 / 2014 CHIEF OF WILDLIFE DIVERSITY LAURA RICHARDS. The commission will establish 2013 / 2014 season dates, species, quotas, limits, closed areas, application procedures and deadlines, and take for raptors for falconry.

The commission will establish 2013 / 2014 season and limits for noncommercial hobby collecting of live, unprotected reptiles and amphibians.
