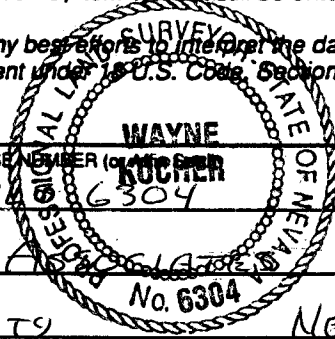
SECTION E CERTIFICATION
