V&T RAILROAD PROJECT PRESENTATION BY THE HISTORIC RAILWAY CORPORATION/INTERWEST MANAGEMENT GROUP - (1-0127) Richard Bilyeu of the Historic Railway Corporation told those assembled that his group is looking for their input on the project. He introduced Art Hannafin and Vern Horton, Corporation Board Members from Carson City, and Paul Yonkers, Board Member from Storey County. Mr. Bilyeu explained the possible public/private endeavor for project startup. He also introduced Paul Lumos, the Corporation's engineering consultant; Richard Carr, principal of Interwest Management of Phoenix, and Grant Holland of Interwest as well. Mike Perry was also at the meeting and was representing Interwest. Mr. Carr invited comments on the project from those assembled.
