A meeting of the Carson City Liquor and Entertainment Board was held during the regularly scheduled Board of Supervisors session on Thursday, June 7, 2007, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, that began at 8:30 a.m.

Mayor Teixeira recessed the Board's of Supervisors session and immediately convened the Liquor and Entertainment Board. A quorum is present, including Sheriff's Representative Schutte. Member Williamson was absent. For Minutes of the Board of Supervisors, see its folder for this date.

ACTION ON APPROVAL OF MINUTES - 5/3/07 (8:45:49) - Member Aldean moved to approve the Minutes from the Carson City Liquor and Entertainment Board meeting of May 3, 2007, as presented. Member Livermore seconded the motion. Motion carried 5-0.

4. TREASURER - Al Kramer

A. ACTION TO CONDITIONALLY APPROVE A BEER AND WINE LICENSE FOR JONATHAN KIMBEN, DOING BUSINESS AS HUNAN GARDEN, LOCATED AT 1480 NORTH CARSON STREET - APPROVAL IS CONDITIONED UPON APPROVAL BY ENVIRONMENTAL CONTROL (8:46:10) - Jonathan Kimben and his interpreter were present. Member Schutte advised that the Sheriff's background check had been conducted and the Sheriff's Office recommended licensing Mr. Kimben. Chairperson Teixeira stressed the importance of not serving minors.

Mr. Kimben indicated that he had been in the business before and is acquiring another business. Clarification indicated that the name "Hunan Garden" will remain. It is a change of ownership. Member Schutte indicated that he was not aware of any problems at the establishment. Chairperson Teixeira stressed the need for Mr. Kimben to use due diligence in operating the business and wished him success. Mr. Kimben indicated that there will be someone on premise who can read a driver's license. Member Staub moved to approve a beer and wine license for Jonathan Kimben, dba Hunan Garden, located at 1480 North Carson Street; approval is conditioned upon approval by Environmental Control; fiscal impact is \$500 for original new fee, \$500 for an investigation fee, and \$150 for a quarterly fee. Member Livermore seconded the motion. Motion carried 5-0.

B. ACTION TO APPROVE A PACKAGED LIQUOR LICENSE FOR PARKHURST INVESTMENT, LLC, DOING BUSINESS AS WINNIE LIQUOR WITH STEVEN PARKHURST AS MEMBER AND LIQUOR MANAGER, LOCATED AT 262 WINNIE LANE (8:49:18) - Mr. Parkhurst was not present. Member Schutte summarized Mr. Parkhurst's background investigation. He advised the Board that in accordance with NRS 244 neither a business license nor a permit may be issued to Mr. Parkhurst due to the delinquent status of his child support payments. Chairperson Teixeira explained his desire to have this information on the record was based on his intent to have Mr. Kramer inform Mr. Parkhurst that he did not need to spend any more time on getting a license in Carson City as it would be an exercise in futility. Mr. Kramer agreed to do so.

Sam Dehne indicated that he admires the police and sheriff's deputies who protect the residents' lives. He did not wish to upset them and he basically supported the decision. The background, however, goes deeper than just Mr. Parkhurst. The business establishment's owner is a victim of double stings. One sting has been removed. He is being forced to sell his business. He has not sold it as Mr. Parkhurst cannot get a business license. He was upset about the sting. There were extenuating circumstances involved. It was a successful sting as the clerk sold liquor to a minor. He felt that the Board should give the owner more time to find another buyer. He had to find a buyer and had taken a loss on the sales price. He is being squeezed into a corner. Mr. Dehne indicated again that he was attempting to defend a citizen without getting "upside down" with the police. He felt that in these circumstances additional time should be given to the owner or that he should be given a second chance. Chairperson Teixeira explained that it was unfortunate that Mr. Dehne had not been present when the Board discussed the matter previously. If he had been, he would have been better informed about the issues. The Board had given him some slack. Mr. Dehne's statements were out of bounds. He then adjourned the Liquor and Entertainment Board and reconvened the session as the Board of Supervisors. No formal action was taken on this item.
