Salaries for Carson City Justices of the Peace

First, we would like to thank you for meeting with us on January 5, 1996 and explaining the new compensation system for the City's unclassified employees. As agreed, we have summarized the results of that meeting as to how the new system would apply to our respective positions:

The salaries for the Justices of the Peace should be handled during the budget process. That is, once the budget is approved, any salary increases contained in the budget would likewise be approved with no further Board action required. A similar conversation was held several months ago with you and Finance Director Mary Walker, the same conclusion was reached.

The Justices of the Peace have traditionally been treated as unclassified employees for salary purposes, having received cost-of-living and merit increases. However, since voters evaluate us at the polls, a pay-for-performance or merit system is not very workable. Therefore, we agree to budget the same cost-of-living increase as unclassified employees are to receive and a standard 5% "merit" increase rather than the new possible maximum cf 7.5%. This would be an on-going policy to be effective July 1 of each year.

It is understood that any "parity" studies to determine prevailing rates of pay for unelassified City employees would also include Justice of the Peace/Municipal Court Judge, and that any salary increase deemed to be warranted from such a study would be applied accordingly.

NRS 4.040 requires that the Board, in July 1996, set the minimum salary for the Justices of the Peace. Last year, when the Department II position was created, the Board set the minimum salary for that position at \$51,000. We suggest that, since cost-of-living increases are tied to positions rather than incumbents, and "merit" increases are tied to incumbents, the Board consider setting the minimum salary for the Department II position by adjusting only for any cost-of-living increases (and any parity studies that are implemented in the future). As of now, that would increase the base to \$52,275 (based on the 2.5% COLA granted in 1995). The minimum salary would be further increased by any 1996 COLA that is approved. The minimum salary for the Department I position should be set the same as the Department II position.

For the record, in attendance at the meeting were John Berkich, City Manager; Mike Griffin, District Court Judge; Bill Milligan, Court Administrator; John Tatro, Justice of the Peace, Department II; and Robey Willis, Justice of the Peace, Department I.

Again, thanks for taking the time to meet with us. We appreciate your efforts in helping reach an amicable solution to what has been a rather unique problem for both the Court and the City in the past. Please let us know if there are any questions or if you need additional information.

Sec. 4.010 Justice Court; Carson City.

1. All provisions of NRS relating to justice courts shall apply to the Justice Court of Carson City.

2. There shall be one township in Carson City, which shall be conterminous with the boundaries of Carson City. (Ch. 213, Stats. 1969 p. 304)

Sec. 4.030 Municipal Court: Judges.

- The justices of the peace of Carson City are ex officio judges of the Municipal Court of Carson City which consists of at least two departments.
- 2. The Board of Supervisors may by ordinance establish a third department of the Municipal Court. The judge of this department must be:
 - (a) A resident of Carson City for a continuous 6-month period immediately preceding his election.

(b) A qualified elector.

- 3. If a third department of the Municipal Court is established, the municipal judge elected for that department serves for a term of 6 years.
- 4. The Board may appoint a municipal judge for a part-time or temporary position. The Board shall establish the hours of service for this position.
- 5. The salary of the judges of the Municipal Court must be fixed by the Board and be paid in the same manner as provided for other elected officers.
