Carson City is the state capital of Nevada. The municipality of Carson City came into being in 1969 when Ormsby County and the City of Carson were incorporated. Law Enforcement services are provided by Carson City Sheriff's Office. Our Mission Statement is, "The Carson City Sheriff's Office is committed to providing the highest level of law enforcement service to the citizens and visitors of our community, while continuously adhering to professional ethical law enforcement standards. The administration and staff are dedicated to building a partnership of trust and respect within the community and enhancing the quality of life in Carson City."

True to our Mission Statement, Carson City Sheriff's Office strives to implement the latest strategies in addressing crime – especially gangs and methamphetamine. The implementation of the Gang Unit and the Special Enforcement Team (S.E.T.) are among the innovative measures used to address these community issues. In a community forum at Carson Middle School, Sheriff Ken Furlong told parents that the priorities for the Sheriff's Office are "gangs, methamphetamine and traffic."

In 2005, the Mayor of Carson City declared methamphetamine to be a critical issue to be addressed and formed a methamphetamine coalition known as Partnership Carson City Sheriff's Office rose to the challenge with the Sheriff, Undersheriff, and other personnel serving on the coalition in various capacities.

Gang issues have been a constant factor, with an obvious increase of gang related crime – including graffiti, vandalism, thefts and violence. Carson City Sheriff's Office has seen a serious escalation in the level of gang related shootings in the past year.

Carson City is encountering growth problems and with it has come an increase of substance abuse, particularly of methamphetamine, and gang related incidents such as graffiti, property destruction, petit larceny, and violent fights and shooting incidents. The Carson City Sheriff's Office is implementing unified teams that use multi-faceted approaches to address methamphetamine and gang issues. Some of our strategies include:

- Law enforcement gang and methamphetamine suppression
- Surveillance
- Arrests
- Knock and Talk (Special Enforcement Team)
- Seizure of currency, vehicles, drugs and stolen property (Special Enforcement Team)
- Intelligence gathering regarding methamphetamine and gang cases
- · Field interviews, interventions and community referral
- Investigation of gang related crimes
- Investigation and arrest of methamphetamine traffickers
- Graffiti and other property damage reporting
- Maintaining statistical data in reference to methamphetamine and gang intelligence

- County and state law enforcement collaboration
- Community outreach, Neighborhood Watch, prevention education and awareness activities (i.e. Cops and Kids-Sheriff's Open House and National Night Out)

The Gang Unit and the Special Enforcement Team work regularly in conjunction with each other and as separate entities. There are two very important points to be made about our teams.

- First, all personnel assigned to either the Gang Unit or the Special Enforcement Team are
 working special details in addition to their regular duties. Officers serving on these teams
 have made a professional and personal commitment that goes over and beyond the call of
 duty which proved especially true in February, 2007, when one of our finest was shot
 while attempting to execute a warrant. Methamphetamine was involved.
- Second, the Carson City Sheriff's Office has carried most of the financial burden of
 getting these units operational. The community response has been overwhelming which
 is positive on one hand, yet creates a dilemma on the other in that the community
 perceived need and actual demand exceeds available manpower.

Carson City Sheriff's Office is working closely with the community to address these issues having partnerships in place with the school district, Chamber of Commerce – Quality of Life Committee, faith-based groups, Partnership Carson City and community agencies.

According to the 2007 Carson City Chamber of Commerce Annual Directory, Carson City encompasses approximately 146 square miles. At the time of the writing of the directory, the population was 57,104 with the ethnicity break down indicating that we have 68% White, 16% Hispanic, 2% Black, 2% Asian, and 12% Other.

According to the Uniform Crime Reporting System, the Carson City Sheriff's Office filed a total of 4,694 crime reports, resulting in 2,735 adult arrests and 464 juvenile arrests in 2006. The statistical data maintained by the Gang Unit indicates that slightly over 1,000 or approximately 20% of the crime reports filed were gang related with the following breakdown:

- 494 miscellaneous gang related crimes
- 425 graffiti reports
- 97 reports of the gang related crimes committed were acts of violence

Our records indicate that Carson City currently has 640 of known gang members or associates. The Gang Unit has worked on 105 of felony cases, 344 of misdemeanor cases, arrested 208 of gang members, and completed 203 field interviews. We see that tensions are building between rival gang members. Carson City is experiencing an increased amount of physical confrontations between gang members, including fights that start on school campus. Graffiti has increased significantly in the past month. Violence has increased with several incidents involving drive-by shootings have occurred in the past few months – some of these have involved methamphetamine and gangs.

The Special Enforcement Team became operational in July, 2006. Since that time, they have used approximately \$45,000.00 in overtime with the following results:

- 181 S.E.T. operations reports completed, resulting in 192 arrests
- 37 Knock and Talk actions regarding methamphetamine, with 16 arrests (also for meth)
- 22 Search Warrants executed 18 of which were for methamphetamine
- 21 arrests for trafficking meth (quantities of 4.0 grams or more)

Seizures include:

- 2.2 pounds of drugs
- \$11,420 U.S. currency
- 6 vehicles 5 of which were methamphetamine related

Officer and citizen safety is of paramount concern. The Special Enforcement Team relies on the S.W.A.T. team to assist when serving high risk warrants.

Again, the violence against citizens and officers is of grave concern. While executing a high risk warrant for crimes involving methamphetamine, one of our finest was shot in the arm. The perpetrator is now facing Attempted Murder charges as well as those listed on the original warrant. A second incident involved Tribal police and Douglas County. Two gang members and known methamphetamine abusers were involved in a high speed chase which resulted in police officers using gunfire. One of the suspects is still at large.

At times, it is difficult to separate gang and methamphetamine issues in that they go hand-in-hand. The statistics listed herein presented separately for both units for the convenience of the reader, however it is imperative to understand that the incidents and data listed herein are often gathered as the units are working together to address methamphetamine and gang issues. In order to address these crimes, the Gang Unit and the Special Enforcement Team need to intensify suppression efforts. All officers working on theses assignments are full-time Deputies serving on the respective teams on a part-time basis. It is not uncommon for them to spot a situation (such as taggers) while responding on a different call.

The Carson City Sheriff's Office is requesting funds to pay over-time for officers to conduct intensive gang and methamphetamine suppression activities in specific areas and using strategies proven to be effective – suppression, intervention and prevention.

Goal 1:

To reduce methamphetamine and gang activity throughout Carson City, thus providing a safer community and improves our "quality of life."

Objective A

The Gang Unit and Special Enforcement Team will increase suppression activities – surveillance, investigations and arrests for gang, graffiti, and methamphetamine crime by 5% respectively. The Special Enforcement Team and the Gang Unit will provide 2,592 (1,296 per team) hours of overtime to work on suppression and outreach activities during the 2007-08 fiscal year. This is the first time these highly focused and intense efforts will be implemented.

Objective B

We will increase the number of crime reports for gang, graffiti and methamphetamine by 3% by increasing community awareness and education in collaboration with the schools, faith-based and youth organizations.

Goal 2:

To increase the amount of intelligence gathered regarding methamphetamine and gang activity by 5%. We will further increase law enforcement visibility and presence in the community.

Objective A

The Gang Unit will increase field interviews and early interventions by 5% from 205 to approximately 230 (we anticipate this to be higher).

Objective B

The Special Enforcement Team will increase Knock and Talk interviews by 5% from 37 to a minimum of 42. We anticipate an increase of arrests during these activities.

Objective C

To increase outreach activities and prevention education to students, parents, schools and members of faith-based organizations. Both prevention classes and awareness activities will increase by 50%.

We plan to continue building and strengthening interactive partnerships with neighborhoods, schools, churches, civic groups and community agencies. Our prevention materials include Carson City Sheriff's Office power point presentations (in place and as developed), Neighborhood Watch, D.A.R.E., etc. Presentations will increase from 100 citizens to 200. Community Outreach participation will increase from 500 to 1,000 through activities including Cops and Kids – Sheriff's Open House, National Night Out, Kit Carson Rendezvous', health fairs and other community functions.

Part 5. METHODS OF ACCOMPLISHMENT

Carson City Sheriff's Office is in the process of implementing common law enforcement practices to reduce gang activity and methamphetamine use and trafficking: **prevention**, **intervention and suppression**. These strategies are also listed a national model set forth in the OJJDP Comprehensive Gang Model and are components of community policing.

The purpose of this project is to implement suppression efforts which will strengthen our prevention and intervention services. According to the model, suppression efforts include arrest, imprisonment and surveillance.

SUPPRESSION:

If funded, the Carson City Sheriff's Office Gang Unit and the Special Enforcement Team will be implementing a concentrated and intense suppression plan specifically focusing on gangs and methamphetamine. Each unit will be allocated over 1,200 hours of overtime to work specifically on gangs and methamphetamine cases without the interruption of regular patrol duties. This will allow officers to complete investigations, follow-up on intelligence leads, conduct surveillances (unmarked vehicles), and patrol (marked and unmarked vehicles) specific areas or neighborhoods identified as having gang and/or methamphetamine activity. Suppression efforts could begin in July, 2007 and work throughout the fiscal 2007-08 fiscal year.

Our suppression activities will also involve field interviews, executing search and arrest warrants, knock and talk activities, interventions (including community referral) and/or arrests will occur. Confidential funds will be used to purchase methamphetamine and information to solve gang related crime.

Preventative measures will model after the traditional law enforcement strengths of high visibility and presence by patrolling (marked vehicles) specific areas to prevent gang, graffiti and methamphetamine related crime.

As previously mentioned, suppression activities can be dangerous as shown when one of the members of the Special Enforcement Team was shot. We are requesting S.W.A.T. vests for the Special Enforcement Team to wear when carrying out duties that are identified to be high risk. We are also requesting night vision equipment Additionally, we have included a request for overtime hours to use the S.W.A.T. team when serving high risk warrants for officer and civilian safety.

OUTREACH AND PREVENTION:

Prevention efforts will be provided for parents, school faculty members and students. Power point presentations created by the Gang Unit and the Special Enforcement Team will be provided. We will also use the anti-methamphetamine presentations from Partnership Carson

City. We will use the Carson City Sheriff's Office Cops and Kids Program to coordinate many of the community outreach activities. The Gang Unit is planning on implementing a parent training involving a Parent Handbook on Gangs. D.A.R.E. is taught for students and has recently added supplemental lessons on both gangs and methamphetamine. D.A.R.E. has also added a family talk component which allows for instruction and educational information to be sent home to parents. Both teams will continue to participate in events such as National Night Out, Cops and Kids – Sheriff's Night Out, and other outreach awareness projects which will increase visibility.

The Chamber of Commerce is actively assisting our outreach efforts by connecting us With members of the clergy who are willing to help with reaching the people and even holding trainings in their facilities. The Chamber of Commerce has also arranged to have a entire publication on gang prevention efforts and area resources to be published through the Nevada Appeal. The Chamber of Commerce is working in conjunction with other agencies to produce an area resource manual, a quick list of resources, and possibly a poster of agencies and telephone numbers. Additionally, the director is also contacting businesses for potential partnership.

INTERVENTION:

The increase of prevention and suppression services will increase the number of interventions and community referrals will increase, also. The parent handbook the Gang Unit is developing lists a wide variety of community resources. Field interviews, school requests and parent interviews and interventions will be conducted as requested.

DOCUMENTATION AND EVALUATION:

We will continue to provide law enforcement efforts, utilizing our Uniform Crime Reporting System, maintaining the gang and special enforcement intelligence systems. An activities log will be kept to mark progress and provide documentation for reporting and evaluation purposes.

Carson City is a very unique community in that when the citizens recognize there is a need or a problem; they rise up to meet the challenge! We know our community and we know what works with our citizens. The aforementioned strategies have proven to work for Carson City Sheriff's Office in the past and we trust that they will continue to be effective.

The program becomes self-sustaining to a point in with the training and equipment being invested directly into our officers. Additionally, officers are able to use their expertise during their regular duties.

The success of this entire endeavor is contingent on collaboration with other law enforcement agencies throughout the state, partnerships with Lion and Douglas Counties, the Carson City School District, churches and area resources.

Carson City Sheriff's Office is actively involved with Partnership Carson City (anti-meth coalition) which is comprised of many service organizations throughout the community, including the Boys and Girls Club, Mentor Center, Community Counseling Center, Parks and Recreation, and several prevention based organizations and coalitions. Many of these organizations will be listed in the community resource section of the parent handbook.

The Southern Nevada Community Gang Task Force has provided invaluable assistance by providing training and in arranging a donation for the first printing of the Parent's Handbook.

Carson City Sheriff's Office has a very strong partnership with the Carson City School District that will be instrumental in delivering services – suppression, intervention and prevention. Additionally, the Gang Unit and Special Enforcement team will provide faculty trainings, specialized presentations, and lessons for students through the Cops and Kids Prevention Program (i.e. DARE, etc.).

The Chamber of Commerce – Quality of Life Committee is actively assisting Carson City Sheriff's Office by assisting with scheduling, connecting resources and partners to us, and in publicity. By working with the Chamber of Commerce, we are developing partners with businesses and the faith-based community.

- 7. Financial management must comply with the requirements of OMB Circulars A-102 or A-110; whichever is applicable to your organization, and which are incorporated into this agreement by reference.
- 8. All grant expenditures are to be reasonable and allowable in accordance with OMB Circular A-21, A-87, or A-122, whichever is applicable to your organization and which are incorporated into this agreement by reference.

- 9. Grantee/sub-grantee shall comply with the audit requirements of the Single Audit Act
 Amendment of 1986 and OMB Circular A-133, which is incorporated into this agreement
 by reference to include the required submission of the most recent annual independent
 audit, as prescribed in sections 310 and 315 and section 320, paragraph f.
- 10. Required documentation for the performance of internal audits must be provided upon OCJA request within 30 days. Grant closeout is contingent upon OCJA audit and resolution of any discrepancies.
