Subject Title: Information regarding the filling of a Transportation Planner position that is contained within the approved CAMPO Budget for Fiscal Year 2007-2008

Staff Summary: The Fiscal Year 2007-2008 CAMPO approved along with the CAMPO Unified Planning Work Program provided for the work program to be delivered primarily by CAMPO staff, which included an additional position. The additional employee was planned to be a Transportation Planner, working almost exclusively on CAMPO-related tasks, which are reimbursable up to 95% by the U.S. Department of Transportation. The Carson City RTC, Douglas County, and Lyon County share the local cost of CAMPO operation, with the local cost only about 10% of total CAMPO costs. The funds to support this position will come primarily from the following work elements of the UPWP:

- 1.1 General Administration and Work Program Oversight
- 1.3 MPO Representation
- 1.6 Public Participation
- 2.1 Update RTP
- 2.2 Update and maintain RTIP
