THE BOARD OF SUPERVISORS OF CARSON CITY DO ORDAIN:

SECTION I:

That Chapter 11.08 of the Carson City Municipal Code is hereby amended as follows:

SECTION II:

That Section 11.08.040 of the Carson City Municipal Code is hereby amended as follows:

11.08.040 [Inspection Fees.] Plan Review, Inspection and Testing Fees.

[Permit and inspection fees, and charges for that portion of the work, if any, to be done by the city in the amounts fixed from time to time by the board shall be paid prior to the issuance of a permit.] A person filing an application for a permit for work regulated by this title shall deposit with the City, the fees contained in Title 18 APPENDIX. The plan review fees shall be deposited at the time of filing the application and the inspection and testing fees shall be deposited prior to permit issuance.

SECTION III:

That Section 11.08.070 of the Carson City Municipal Code is hereby deleted in its entirety as follows:
