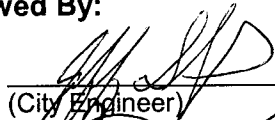

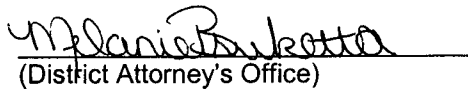

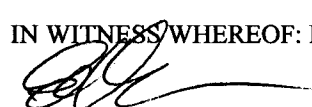

TAXES shall be prorated and abated in accordance with Section 361.484 N.R.S.

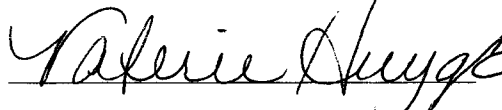
