Board of Supervisors approval of the Project Agreement will allow City staff to proceed with the project and implement a portion of the Edmonds Sports Complex Master Plan. Explanation for Recommended Board Action: The addition of the lighting system was approved as part of a Master Plan for the site approved by the Carson City Parks and Recreation Commission, Carson City Planning Commission, and ultimately the Board of Supervisors in 1998. The project will allow the non-profit user group of the facility, Carson City BMX, to attract more participation and larger events if a quality outdoor lighting system were in place. Applicable Statute, Code, Policy, Rule or Regulation: Nevada Revised Statutes 277.180 Fiscal Impact: N/A Explanation of Impact: Approval of this project agreement contract provides Carson City with funds to be used towards the installation of overhead nighttime lighting including wiring and poles at the BMX Track in the Edmonds Sports Complex. The State of Nevada, represented by the State Liaison Officer, and the Participant named above mutually agree to perform this agreement in accordance with the Land and Water Conservation Fund Act of 1965, 78 Stat. 897 (1964) and with the terms, promises, conditions, plans, specifications, estimates, procedures, project proposals, maps and assurances attached hereto and hereby a part hereof.

The State of Nevada hereby promises, in consideration of the promises made by the Participant herein, to take the necessary steps and action and to attempt to enter into an agreement to obtain Federal money for that portion of the project referred to as Federal Grant above, to accept such funds from the United States and to tender to the Participant that portion of the obligation which is required to pay the United States' share.

It is understood by the parties hereto that this agreement shall not obligate State funds for the project cost described herein except those costs necessary for administration of the project.

In the event construction has not commenced on this project within ten and one half $(10\frac{1}{2})$ months from the date of official notification of funding from the Division of State Parks (Notice to Proceed), this agreement is null and void. In the event an acquisition does not take place within nine (9) months from the date of official notification of funding from the Division of State Parks (Notice to Proceed), this agreement is null and void.

The Participant hereby promises, in consideration of the promises made by the State of Nevada herein, to execute the project described above in accordance with the terms of this agreement.

The following special project terms and conditions were added to this agreement before it was signed by the parties hereto:
