**DEVELOPMENT SERVICES - PLANNING - Director Walter Sullivan** 

A. ACTION TO APPROVE A 'DINING ROOM WITH BEER AND WINE' LIQUOR LICENSE FOR EVANGELINA VELASCO, DOING BUSINESS AS TAQUERIA LA GUADA-LUPANA, LOCATED AT 2495 NORTH CARSON STREET, CARSON CITY (8:35:20) - Evangelina Velasco - Member Furlong advised that the Sheriff's Office did not object to her having a Liquor License. The background check was complete. He also disclosed that she is a legal alien whose Green Card expires in June 2009. She must obtain another card or have the current card extended if she does not obtain citizenship before that date. Ms. Velasco indicated that she is aware of this condition and agreed to it. Discussion explained the location of the establishment and that she will be allowed to sell liquor for on premise use only. Outside sales will not be allowed. Chairperson Teixeira cautioned her against the sale of beer and wine to minors. He also reminded her of the condition mandating that all servers and sellers attend the Sheriff's servers training class. Additional comments were solicited but none were given. Member
