Subject Title: Action to approve Carson River Park's Phase II conceptual site development plan.

Staff Summary: Carson River Park is one of several important recreation facilities located along the Carson River in the City's park system. In addition, this park is identified as a critical "put in" facility in the Carson River Aquatic Trail Master Plan. City staff has completed the design for the Phase II conceptual site development plan and is requesting approval by the Board of Supervisors. This approval will allow City staff to proceed with the project by acquiring the necessary environmental, building, and engineering permits on the City's behalf and develop Phase II construction documents for bidding and constructing the project to enhance this existing outdoor recreation facility.

Explanation for Recommended Board Action: As project background, the Carson River Park Master Plan was approved by the Board of Supervisors on December 3, 1998. Included within this plan was a two-acre polygon located on the Silver Saddle Ranch, Bureau of Land Management property for future expansion of Carson River Park. At that time of Board of Supervisors approval, there was no site plan developed for the Phase II area, only identified program elements which could be potentially incorporated into a site design at a later date (Refer to Exhibit A).

At the beginning of this year, the Parks and Recreation Department worked with the Carson River Park technical advisory committee to develop the Phase II conceptual site development plan for this area (Refer to Exhibit B). The technical advisory committee members included the consultant team (Hansen Landscape Architects and Wood Rodgers), representatives from the Carson River Advisory Committee, Parks and Recreation Commission, Bureau of Land Management/Carson City Field Office, Carson Valley Conservation District, and Nevada Division of State Lands. The Parks and Recreation Department staff will present the site design concepts for the Carson River Park's Phase II area at this meeting and will seek approval from the Board of Supervisors. If the Board approves this project, our department will move forward to acquire the necessary special use permit; environmental, building, and engineering permits; and various federal and state permits to construct this project.

Explanation of Impact: Not applicable at this time

Funding Source: Using the Carson River Park Master Plan, the Parks and Recreation Department applied for and has received to date \$153,048 in grant funding and \$75,000 in Residential Construction Tax funding for this project. The project funding partners are the Carson Water Subconservency District and Nevada State Lands / Question-1. These funds have paid for this conceptual site development plan. In addition, our department will use the remaining funds to complete the project's Phase II construction and develop the site improvement documents.

2) Request modifications to the Phase II conceptual site development plan.

Discussion: The Carson River Advisory Committee has been in the process of developing the Carson River Master Plan for the past year and a half. This project was put on hold by the committee for the past year due to the acquisition of the Silver Saddle Ranch by the Bureau of Land Management. The reason for putting the project on hold was to allow B.L.M. time to develop plans for the Silver Saddle Ranch. GENERAL DISCUSSION:

The Carson River Advisory Committee (C.R.A.C.) has been developing the Carson River Park Master Plan for the past year and half. This project has been on hold the past year due to the acquisition of the Silver Saddle Ranch by the Bureau of Land Management (B.L.M.). The committee's reason for putting the project on hold was to allow B.L.M. time to develop plans for the Silver Saddle Ranch. B.L.M. is now in the final stages of plan development and C.R.A.C. feels they have enough information about B.L.M.'s Silver Saddle plans to move forward and complete the Master Plan for Carson River Park.

APPLICANT'S JUSTIFICATION:

C.R.A.C. members, Rich Shock from Stantech Consulting, Parks staff, and B.L.M. staff have been working together to plan Carson River Park and integrate the two facilities. After the establishment of C.R.A.C., development and implementation of this master plan has been the committee's highest priority.

Staff and the Carson River Advisory Committee are excited about this plan and its future implementation. 




WELL HOUSE CONCEPT

REQUEST:

Action to recommend to the Planning Commission and Board of Supervisors adoption of the Carson River Park Master Plan, including the Phase II Conceptual Site Development

Plan.

GENERAL DISCUSSION:

As project background, the Carson River Park Master Plan was approved by the Board of Supervisors on December 3, 1998 (Refer to Exhibit A). Included within this plan was a two-acre polygon located on the Silver Saddle Ranch, Bureau of Land Management property for future expansion of Carson River Park. At the time of Board of Supervisors approval, there was no site plan developed for this area, only identified program elements which would be incorporated into a site design at a later date. Using this Master Plan, Parks and Recreation Department staff applied for and received Residential Construction Tax and Question 1 funds for the design and construction of this two-acre polygon area which is now referred to by City staff as Carson River Park, Phase II.

Over the past three months, the Parks and Recreation Department has been working with the Carson River Park technical advisory committee to develop a Phase II conceptual site development plan (Refer to Exhibit B). The technical advisory committee members include the consultant team (Hansen Landscape Architects and Wood Rodgers), representatives from the Carson River Advisory Committee, Parks and Recreation Commission, Bureau of Land Management / Carson City Field Office, Carson Valley Conservation District, and Nevada Division of State Lands. The Parks and Recreation Department and the consultant team will present the site design concepts for Phase II at this meeting. City staff will seek comments from the Commission and public regarding this concept plan and the project's construction implementation strategies.

RECOMMENDED ACTION:

I move to recommend to the Planning Commission and Board of Supervisors adoption of the Carson River Park Master Plan, including the Phase II Conceptual Site

requested the commission to include Mr. Geddes' proposed introduction language as part of the motion. Vice Chairperson Livermore advised that he had referenced Mr. Geddes' proposed introduction. Commissioner Shabi seconded the motion. Motion carried 7-0. Chairperson Curtis thanked City staff and members of the RTC / CAMPO for their attendance and participation.

5-C. ACTION TO RECOMMEND TO THE PLANNING COMMISSION AND THE BOARD OF SUPERVISORS ADOPTION OF THE CARSON RIVER PARK MASTER PLAN, INCLUDING THE PHASE II CONCEPTUAL SITE DEVELOPMENT PLAN (7:01:19) - Chairperson Curtis introduced this item and, at Mr. Krahn's request, recessed the meeting at 7:01 p.m. She reconvened the meeting at 7:06 p.m. Mr. Krahn reviewed the staff report and introduced Ryan Hansen, of Hansen Landscape Architects.

(7:09:36) Mr. Hansen provided background information on the work group meetings associated with the subject project, and reviewed elements considered at said meetings. The list, which was displayed in the meeting room, included debris deflection, FEMA flood way location, water rights and the existing well, landscape improvements and irrigation, trails to be maintained or connected, a hybrid park with a natural focus, passive recreation, non-traditional play structures, and interpretive education. Mr. Hansen reviewed conceptual drawings which were displayed in the meeting room.

In response to a question, Mr. Krahn advised that the well house is operational and that Public Works staff has indicated no problem with using the well for irrigation. Mr. Krahn discussed the importance of naintaining the Silver Saddle Ranch character in the conceptual design, and reviewed the associated elements in conjunction with the displayed drawing. He advised that staff will continue to work with the consultants to define the first phase of the project according to available funding. He expressed appreciation for the input provided by the working group, for the expertise of the consultants, and for the participation of City staff. He described the plan as simple with amenities that will enhance the park and the Carson River Aquatic Trail access. In response to a question, he discussed the public process associated with the Carson River Master Plan element, beginning in 1998, and opportunities made available for public input since that time. He acknowledged a plan for improvements on the opposite side of the River.

Commissioner Keeton inquired as to the possibility of planting deciduous trees near the picnic tables to provide shade. Mr. Krahn acknowledged this as a possibility as the plan moves forward to final design. Commissioner Adams suggested relocating the picnic table presently depicted near the restroom enclosures. Chairperson Curtis called for public comment and, when none was forthcoming, entertained a motion. Commissioner Westergard moved to recommend to the Planning Commission and the Board of Supervisors adoption of the Carson River Park Master Plan, including the phase II conceptual site development plan. Commissioner Keeton seconded the motion. In response to a question, Mr. Krahn reviewed trail access to the open space properties. Chairperson Curtis called for a vote on the pending motion; motion carried 7-0.

5-D. ACTION TO RECOMMEND TO THE PLANNING COMMISSION AND THE BOARD OF SUPERVISORS ADOPTION OF THE MORGAN MILL ROAD RIVER ACCESS REA CONCEPTUAL SITE DEVELOPMENT PLAN (7:27:37) - Chairperson Curtis introduced this Item. Mr. Krahn provided historic information on the site, and reviewed the staff report.
