Events Source Productions (John Procaccini) will be providing staging construction and support for Downtown Carson City's summer events.

## The budget:

- 1. Layout and schematics for event locations \$1,000
- 2. Stage construction \$15,972
- 3. Family activity plaza \$17,250
- 4. Production and coordination \$18,000
- 5. Contingency \$7,778
- 6. Total: \$60,000

This staging equipment and production coordination will become an integral part of numerous Downtown events: music, children's theater, presentations and so forth. We anticipate events at West Proctor, East Proctor, Third Street and Telegraph Square throughout the summer and fall. Just to name a few, potential users of the staging and production support include the collaboration with the following:
