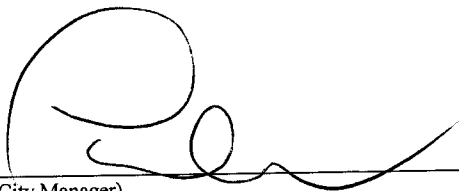

RESOLUTION NO. _____

A RESOLUTION ENCOURAGING THE MEDICAL COMMUNITY AND THE
RESIDENTS OF CARSON CITY TO PARTICIPATE IN THE CARSON CITY
ANONYMOUS DRUG DESTRUCTION PROGRAM

WHEREAS, the Federal government recently issued new prescription drug guidelines urging Americans to dispose of prescription drugs safely to reduce the diversion of these drugs while also protecting the environment; and

WHEREAS, among these guidelines is the recommendation that all unused, unneeded, and expired prescription drugs be taken to pharmaceutical take-back sites that allow the public to bring unused drugs to a central location for safe disposal; and

WHEREAS, the Carson City Sheriff's Office has an existing system for the disposal of illegal drugs and is willing to expand the program to include the pick-up and receipt of prescription drugs as well; and

WHEREAS, pursuant to the general guidelines of the Sheriff's Office Drug Destruction Program, members of the public may turn in drugs of any kind anonymously Monday through Friday during regular business hours.

NOW, THEREFORE, BE IT RESOLVED that the Carson City Board of Supervisors does hereby encourage local residents, hospice caregivers and other medical personnel and facilities to dispose of all unused, unneeded or expired prescription drugs in a responsible way by delivering them to the Carson City Sheriff's Office or by requesting pick-up by the Sheriff's Volunteers in Police Service (VIPS) program in order to keep these drugs out of the community water system, out of the landfill and out of the hands of those who would misuse them.
