AN ORDINANCE AMENDING CARSON CITY MUNICIPAL CODE TITLE 18, ZONING, CHAPTER 18.03, DEFINITIONS, SECTION 18.03.010, WORDS AND TERMS DEFINED, BY MODIFYING THE DEFINITION OF CHILD CARE FACILITY, AND OTHER MATTERS PROPERLY RELATED THERETO.

The Board of Supervisors of Carson City does ordain:

SECTION I:

That Chapter 18.03 (Definitions), section 18.03.010 (Words and Terms Defined) of the Carson City Municipal Code is hereby amended, in part, by modifying the definition of "Child Care Facility" as follows (stricken text is deleted, <u>underlined</u> text is added):

18.03.010 Words and Terms Defined.

Child Care Facility means any place, home, institution or establishment in which more than five <u>six</u> children are received, cared for or maintained for any period of time with or without compensation.

SECTION II:

That no other provisions of Title 18 of the Carson City Municipal Code are affected by this ordinance.
