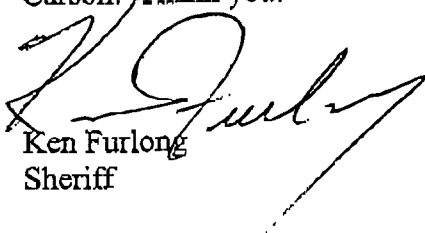

Subject: Bravery awards

I am requesting two young men who put their lives on the line to protect others be nominated for the Carson City Sheriff's Office awards for bravery.

Two young men who deserve awards for bravery - Bryan Neddenriep and Robert Carrillo. Per our conversation, I would like to nominate these two young men from our community for such awards.

On February 29, 2008 an incident occurred where a young man, Shannon Marsh, went across the street from where friends were walking in front of Gottschalks to get a bottle of water. As he walked by, a disturbed man, James Redmon, was yelling and screaming and he whirled on Mr. Marsh and slit his throat wide open. Mr. Marsh's friend, Bryan Neddenriep raced across the street and tackled James Redmon and hit him twice and knocked the knife out of his hand.

The second incident occurred on April 7, 2008. When John Emmanuel Lara and two other adult males were harassing kids at the Silver Oak Skateboard park. Robert Carrillo saw what was happening and told them to stop it and leave the teenagers alone. Almost immediately one of the adults with Mr. Lara started fighting with Mr. Carrillo at this time, Lara came up behind Mr. Carrillo and slashed him in the back and in the back of the neck with a knife.

This act of protecting these youngsters will leave him scarred for life.

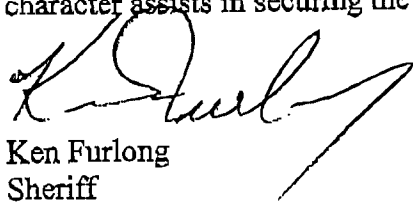

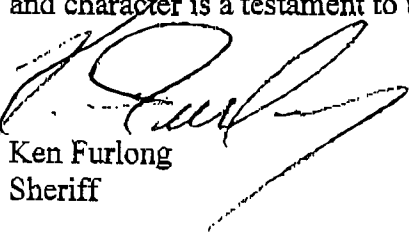

On February 29, 2008, the Carson City Sheriff's Office and Fire/Medical Department responded to a report of a man who had been stabbed in the throat. Upon examination, the victim was treated for a severe slash extending from center of his throat and circling around to the side. The injury was severe and life threatening.

Unlike most incidents that public safety resources respond to, the first person located was the suspect. Our investigation has revealed that when the victim was attacked, you ran across the street, tackled the suspect and disarmed him. This selfless disregard for your own health and welfare ensured that the belligerent aggressive actions of another did not go unpunished. And, through your own actions, you may well have saved the life of a young man.
