**Staff Summary:** The properties located within a portion of Section 9 and Section 17 (T. 15 N. R. 20 E.) were purchased by Carson City on September 18, 2008 under a Contract of Sale agreement (Parcel #'s 007-031-04 and 007-091-26). On January 9, 2009 a deed was recorded completing the contract and thereby transferring legal ownership to Carson City. This property is now tax exempt per NRS 361.060. The Assessor's office is asking that the taxes be prorated from July 1, 2008 thru January 9, 2009 and that the remaining amount be removed from the 2008/09 Real Property Tax Roll.
