WHEREAS, NRS 355.172 authorizes securities purchased as an investment of money by or on behalf of Carson City to be in the possession of a qualified bank or trust;

WHEREAS, NRS 355.178 authorizes the lending of securities from Carson City's investment portfolio;

WHEREAS, the Carson City Board of Supervisors has approved a contract with the Bank of New York Mellon Trust Company in which Bank of New York Mellon Trust Company maintains possession of securities purchased as an investment of money by or on behalf of Carson City;

WHEREAS, Section 3.045 of the Carson City Charter provides that the duties of the Carson City Treasurer include the investing the surplus money of Carson City; and

WHEREAS, the Carson City Board of Supervisors recognizes that the proper person to represent Carson City in matters concerning the contract by and between Carson City and the Bank of New York Mellon Trust Company is the Carson City Treasurer.

NOW, THEREFORE, BE IT RESOLVED that the Carson City Board of Supervisors does authorize the Carson City Treasurer, Alvin P. Kramer, to represent Carson City on matters related to and to sign on behalf of Carson City any documents required for the fulfillment of the contract by and between Carson City and the Bank of New York Mellon Trust Company.
