RIGHT-OF-ENTRY

This Agreement is made this _____ day of _____, 2009 between Carson City, Nevada (Grantor), and Douglas County, a political subdivision of the State of Nevada, (Grantee).

WITNESSETH

This Agreement will facilitate the implementation of the INTERLOCAL AGREEMENT entered into by the parties as approved by the Douglas County Board of Commissioners on October 16, 2009 pertinent to Grantee utilizing Grantor's excess wastewater treatment capacity. The Grantor presents to the Grantee the right-of-entry for the purpose of location, construction, access, maintenance, repair and replacement of Grantee public utilities, including a sewage force main and necessary incidents thereto, upon, over, under, across and through the real property to fully implement said INTERLOCAL AGREEMENT. The property pertinent to this right-of-entry includes, but may not be limited to, the real property situated within a portion of Section 6 T14N, R20E, MSM and Section 31 T15N, R20E, MSM, Carson City Nevada, and being more particularly described in the legal descriptions shown on Exhibits "A," "B" and "C" with maps attached thereto, together with all and singular tenements, hereditaments, and appurtenances belonging to or in anyway appertaining to this property. This Agreement shall continue in force and effect while the aforementioned INTERLOCAL AGREEMENT remains in force and affect, and until the Grantee has completed its project to remove the force main upon the termination or conclusion of the INTERLOCAL AGREEMENT.






