The Liquor and Entertainment Board voted to impose disciplinary action of a \$500.00 fine to be paid within 30 days from November 5, 2009, the requirement that all employees selling, dispensing, or serving liquor attend the alcohol servers' training program, and the liquor license holder or the responsible party appear at the November 19, 2009 Liquor and Entertainment Board meeting.
