SECTION I:

That the Carson City Municipal Code Title 18, Zoning, Chapter 18.03, Definitions, Section 18.03.010, Words and Terms Defined, is hereby amended, in part, by amending the definition of "Animals and Fowl," as follows:

18.03.010 Words and Terms Defined.

Animals and Fowl means the keeping of horses, swine, fowl, sheep or other animals of a similar nature. Notwithstanding the zoning regulations of this title, the keeping of animals [are] is regulated and further defined under Carson City Municipal Code Title 7, Animals.

SECTION II:

No other provisions of Title 18 of the Carson City Municipal Code are affected by this ordinance.
