WHEREAS, the parties to the Agreement between the State of Nevada, acting by and through its Department of Public Safety, Records and Technology Division, Records Bureau, and Carson City, a consolidated municipality and political subdivision of the State of Nevada, on behalf of the Carson City Human Resources Department, to use the Civil Name Check Program, desire to adopt and approve such agreement as required by NRS 277.180. A copy of the agreement is attached to this Resolution as Exhibit "A;" and
