Staff Summary: CCMC 4.13.160 provides for an emergency summary suspension by the Sheriff, his designee, or the Board if determined that the continued operation of the licensed premises constitutes a clear and immediate threat to the health, safety, and welfare of the residents of Carson City. On September 2, 2010, the Sheriff summarily suspended Liquor License #11-27238 (catering portion only) based on an event located at 1700 Forrest Way held on August 20, 2010.

Mr. Schmitt:

In accordance with the Carson City Municipal Code, 4.13.160 Emergency Summary Suspension, Sheriff Furlong has immediately suspended the issued catering liquor license on the determination that the continued operation of the licensed premises constitutes a clear and immediate threat to the health, safety, and welfare of the residents of Carson City.

Stated below are the grounds for suspension, per Sheriff Furlong:

On August 20, 2010, the holder of a catering liquor license, Mr. Schmitt, was permitted to hold a concert at his own property located at 1700 Forrest Way, Carson City, NV. Sheriff's Office staff conducted a business check of the event and determined the following:

- The contract security for the event as permitted was not on site.
- Gang graffiti was painted on the interior wall in clear view of all participants at some time before the event began.
- Security personnel (at least one) were identified as known violent documented gang members from the local area.
- No license for the sale of alcohol was on the premise; later retrieved as a catering license.
- The owner described the bar as temporary, yet it was observed as a permanent fixture.
- The owner pledged he was not aware of any gang problems, yet a sign was posted at the entry point "No Guns" and gang graffiti was evident.

Proctor Street • Carson City, Nevada 89701 Phone: (775) 887-2105 Fax: (775) 887-2202 buslic@carson.org Sheriff Furlong determined that the owner of the license, Com Productions, LLC and Mr. Schmitt, hosted a Rap Concert that was a clear and immediate threat to the health, safety and welfare of the residents of Carson City, based on the information above. Mr. Schmitt knew or reasonably should have known and was well aware or reasonably should have been aware that the concert was catering to gang activities in a warehouse bordering a residential zone, and that it was a clear and immediate threat to the health, welfare, and safety of the community.

This suspension is intended for the liquor catering license held by Mr. Schmitt and is not to effect the license he holds for his business located at 4750 Hwy 50 East, Ste. 1 in Carson City.

This suspension shall remain in effect until the next meeting of the Carson City Liquor Board at which time a show cause hearing will be conducted. The next meeting of the Liquor Board will be held on September 16, 2010 at 8:30a.
