REQUEST:

Action to recommend to the Board of Supervisors a work program for 2011.

GENERAL DISCUSSION:

The information below summarizes and organizes projects and other tasks being conducted in order to carry out the functions and responsibilities of the Open Space Program, as outlined by the provision of Chapter 13.06 of the Carson City Municipal Code. The information is organized into four main categories: 1) Land transactions in progress, 2) Management activities, 3) Planning activities, and 4) Capital improvement projects. This work program outline will be used by staff as a precursor for the preparation of the budget and to provide an opportunity for the committee and Board of Supervisors to discuss and request information on the wide range of projects we may work on in the future.

The Open Space Program has reached the point where emphasis has switched from land acquisition to land management.

The last page of this report summarizes the properties acquired through the Question-18 Open Space Program and in City ownership and, in the case of Horsecreek, a partial interest through a conservation easement.

1. LAND TRANSACTIONS IN PROGRESS

Long, Darling, and Schulz	SNPLMA waiting for funding for purchase by the U.S. Forest Service for Long and Darling. Schulz is funded and the USFS anticipates commencing purchase by June 2011.
Joost property	Transaction to be completed by Public Works, purchase of approximately 40 acres.
Potter property	OSAC recommended a transfer of lands with City properties.
Schulz conservation easement (Woods Ranch)	NRCS grant funding not approved - awaiting other opportunities for funding.
Collard conservation easement (Kings Canyon)	On hold by proponents due to depressed economy.
Bently property	SNPLMA funding approved for purchase by Carson City. Transaction negotiated in principle as a joint venture with the V&T and escrow opened.
Donation of property on Lompa Lane in relation to wetlands under the present ownership of Dwight Millard and Jim Bawden	31 Acres - Staff to develop agreements to facilitate transaction. The work for this transaction has been delayed due to other more urgent priorities.

Lands Bills - Transfers	 A. US Forest Service transfer - due diligence work almost completed. Deeds of correction at the Board of Supervisors meeting on 4-21-11. B. BLM work for Silver Saddle Ranch: Management plan (in progress), conservation easement (completed), and NEPA by BLM (in progress).
Benna-Marshall 45.5 acres at Carson Range / Ash Canyon	The Legacy grant project may be funded in 2013.
V&T Trail right-of-way, north of Combs Canyon Road	Obtaining easements through consultants.

Volunteer opportunities / activities	Programmatic - our two volunteers are ready to start the 2011 tour. Working with Friends of Silver Saddle Ranch and Muscle-Powered.
Fuels reduction projects	Programmatic - NDF to initiate when road access is clear of snow. Wilson property treatments are subject to the resolution of the State budget.
Management of Waterfall Fire and Utility lands (NRCS grants)	Programmatic - Phase III being managed by Public Works.
Silver Saddle Ranch Charrette Process implementation	FOSSR and the Sierra Business Council produced marketing materials aimed at increasing the capacity of the FOSSR.
Continue forest rehabilitation efforts	Programmatic - based on opportunities
Noxious weed control activities	We continue to collaborate with the Carson Weed Coalition towards necessary treatments.
Jarrard Ranch home demolition and cleanup, and signage at the former Serpa property at the Carson River Canyon.	Management assessment and required implementation of transition of immediate management needs in progress.
Ash Canyon Road	Annual maintenance as required.

4. CAPITAL IMPROVEMENT PROJECTS

NRCS Grant - Flood and debris mitigation project at Quill Ranch / Long Ranch	Phase III NRCS grant \$360,000 under design
Mexican Ditch Trail Extension (Moffat property)	Through the efforts of RTC/Safe Route to Schools grants - project delayed due to grant problems.
Kings to Ash Canyon multi-purpose trail by Muscle-Powered	NEPA work under the U.S. Forest Service direction and with Muscle-Powered and staff collaboration. There may be an opportunity to construct segments within City lands.
Waterfall Trail	90% of new trail completed through Eagle Scout project by Dion Copoulos. We will finish this project with volunteers and crews.

Programmatic means that the substantial majority of the cost is absorbed by staff's daily routine work and existing budget line items.
