Parks and Recreation Commission Goals for 2011

1. Promote, develop, fund, construct, and market trails and associated facilities that provide running, biking, walking, and aquatic opportunities and events.

Example: Complete and submit an application to achieve a "Runner Friendly Community" for Carson City.

2. Promote healthy lifestyle programs by collaborating with other organizations and agencies.

Example: Investigate into participating in First Lady Michelle Obama's "Lets Move" program.

3. Review and prioritize Quality of Life capital projects and make recommendations to the Board of Supervisors.

4. Continue to support a Volunteer Coordinator position within the Parks and Recreation Department that would have little or no financial impact to the City.

Example: Investigate a college work study or intern program or advertise for experienced volunteers.

5. Continue to encourage neighborhood volunteer programs and projects as well as the Adopt-A-Park program.
