Subject Title: For Possible Action: To adopt a Resolution providing for the transfer of Carson City's share of the 2011 private activity bond cap to the Nevada Rural Housing Authority and other matter properly related thereto. (Janice Brod)

Summary: Carson City may annually allocate a share of State money set aside for tax exempt loans for industrial development and affordable housing projects, referred to by the State as "private activity bond volume cap." Carson City may allocate its share to specific projects that apply and qualify with the State, or the allocation goes back into the general State-wide pool.

Recommended Board Action: I move to adopt Resolution Number 2011-R-_____, a resolution providing for the transfer of Carson City's share of the 2011 private activity bond cap to the Nevada Rural Housing Authority and other matter properly related thereto.

Explanation for Recommended Board Action: No other applications for allocation of the City's share of the State private activity bond volume cap were received. Nevada Rural Housing Authority has implemented four tax-exempt bond programs, helping nearly 900 families purchase their first home. These programs have resulted in \$148 million dollars of mortgage loan activity, provided over \$4.2 million dollars in down payment assistance grants, and \$3.1 million dollars in tax savings.

RESOLUTION NO. 2011-R-

RESOLUTION PROVIDING FOR THE TRANSFER OF CARSON CITY'S SHARE OF THE 2011 PRIVATE ACTIVITY BOND CAP TO THE NEVADA RURAL HOUSING AUTHORITY AND OTHER MATTERS PROPERLY RELATED THERETO.

WHEREAS, pursuant to the provisions of Ch. 348A of the Nevada Revised Statutes ("NRS") and Ch. 348A of the Nevada Administrative Code ("NAC"), there has been allocated to Carson City, Nevada (the "County" and the "State", respectively), the amount of \$2,847,400.24 in tax-exempt private activity bond cap for calendar year 2011 ("2011 Bond Cap"); and

WHEREAS, the Nevada Rural Housing Authority ("NRHA"), has requested that the County transfer its 2011 Bond Cap to NRHA for the purpose of providing a means of financing the costs of single family residential housing that will provide decent, safe and sanitary dwellings at affordable prices for persons of low and moderate income ("Single Family Program"); and

WHEREAS, the County is a local government as defined by NAC 348A.070; and

WHEREAS, Section 348A.180 of the NAC provides a procedure whereby the County may, by resolution, transfer to any other local government located within the same county, all or any portion of its 2011 Bond Cap; and

WHEREAS, pursuant to NRS 315.983(1)(a), NRHA is an instrumentality, local government and political subdivision of the State; and

WHEREAS, NRHA is located within Carson City, pursuant to NRS 315.963, which defines NRHA's area of operation as "any area of the State which is not included within the corporate limits of a city or town having a population of 100,000 or more" ("Area of Operation"); and

WHEREAS, it is the intent of NRHA, to the extent tax-exempt private activity bond cap is available ("NRHA Bond Cap"), to match the 2011 Bond Cap transferred to NRHA pursuant to this Resolution for Single Family Program in County in accordance with the terms and conditions herein contained.

NOW, THEREFORE, the Board of Supervisors of the County does hereby find, resolve, determine and order as follows:

<u>Section 1</u>. <u>Recitals</u>. The recitals set forth herein above are true and correct in all respects.

<u>Section 2.</u> <u>Transfer of Private Activity Bond Cap</u>. Pursuant to NAC 348A.180, County hereby transfers, 2011 Bond Cap in the amount of \$2,847,400.24 to the NRHA for its Single Family Program.

<u>Section 3.</u> <u>Conditions on Transfer</u>. The transfer made in Section 2 is subject to the conditions contained within this Section. Prior to using the 2011 Bond Cap outside of County, NRHA shall, through its Single Family Programs, for a period of ninety (90) days make a commercially reasonable attempt to originate loans or issue mortgage credit certificates, as applicable, within County in an amount at least equal to the 2011 Bond Cap, plus any matching NRHA Bond Cap. After ninety (90) days of NRHA's using the 2011 Bond Cap for issuance of single family mortgage revenue bonds, or in exchange for the authority to issue mortgage credit certificates, all geographic conditions imposed by County on NRHA's use of the 2011 Bond Cap shall terminate, and NRHA shall be free to originate loans anywhere within its Area of Operation. NRHA will use the 2011 Bond Cap for single family purposes in calendar year 2011, or carry forward any remaining amount according to the tax code for such purposes.

<u>Section 4.</u> <u>Representative of County</u>. Pursuant to NAC 348A.180(1), the Director may contact Richard F. Jost, Esq., on behalf of Jones Vargas, Special counsel to County regarding this resolution at (702) 862-3383 or in writing c/o Jones Vargas, 3773 Howard Hughes Parkway, Third Floor South, Las Vegas, Nevada 89109.

<u>Section 5.</u> <u>Additional Action</u>. The Chairman and Clerk of the County are hereby authorized and directed to take all actions as necessary to effectuate the transfer of the 2011 Bond Cap, and carry out the duties of County hereunder, including the execution of all certificates pertaining to the transfer as required by NAC Ch. 348A.

<u>Section 6.</u> <u>Direction to NRHA</u>. NRHA shall notify the Director in writing as soon as practicable of the occurrence or nonoccurrence of any term or condition that would affect the disposition of the 2011 Bond Cap.

<u>Section 7</u>. <u>Representative of NRHA</u>. Pursuant to NAC 348A.180(3), the Director may contact Richard F. Jost, Esq., on behalf of Jones Vargas, counsel to NRHA regarding this resolution at (702) 862-3383 or in writing c/o Jones Vargas, 3773 Howard Hughes Parkway, Third Floor South, Las Vegas, Nevada 89109.

<u>Section 8</u>. <u>Obligations of County</u>. This Resolution is not to be construed as a pledge of the faith and credit of or by the County, or of any agency, instrumentality, or subdivision of the County. Nothing in this Resolution obligates or authorizes the County to issue bonds for any project or to grant approvals for a project or constitutes a representation that such bonds will be issued.

<u>Section 9</u>. <u>Enforceability</u>. If any section, paragraph, clause or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the

remaining provisions of this resolution. This resolution shall go into effect immediately upon its passage.

Dear Mr. Werner:

Earlier this year you received a notice from the State of Nevada Department of Business and Industry regarding your share of the 2011 Private Activity Bond (PAB) Cap allocation (attached).

NRHA has implemented four tax-exempt bond programs under "Home at Last" using transferred allocations from the cities and counties.

In 2009, NRHA announced our newest "Home at Last" product, the Mortgage Credit Certificate (MCC) Program, the first MCC program in Nevada's history. Like bond programs, the MCC helps rural Nevadans purchase their first home. It provides a dollar-for-dollar federal income tax credit equal to 20% or 30% of the interest paid on a mortgage loan. We recently implemented our second MCC Program. The MCC Programs also use our PABC allocation.

THIS WOULD NOT HAVE HAPPENED WITHOUT THE TRANSFERS OF PRIVATE ACTIVITY BOND CAP FROM EACH OF YOU AND THE MATCHING FUNDS PROVIDED THROUGH THE PRIVATE ACTIVITY BOND CAP COMMITTEE.

We estimate the average family in our MCC program will save \$2,000 per year and this savings will continue every year based upon the actual interest paid.

Since 2006, we have been very proud that both the bond and MCC programs responded to the Nevada Legislature intent of sharing the Private Activity Bond Cap allocation with the cities and counties. It also stimulates the economy and helps jurisdictions maintain or increase their tax base.

The catalyst for all these programs is the transfer/matching funds concept. That concept has led to the wonderful partnership that NRHA now has with the rural cities and counties. It is a win-win-win for the state, the cities and the counties, but mostly for the families.

We are requesting Carson City's unused PAB allocation for 2011. The process requires a resolution and transfer certificate, which needs to be signed and forwarded immediately following your meeting, as these items must be turned in to the Division of Business and Industry within three days.

Nevada Rural Housing Authority will also be asking for matching funds from the Private Activity Bond Cap Committee. The continued success of our programs is predicated on your transfer and the transfer from the other cities and counties.

We would like to request that you schedule this item for your next available Board of Supervisors meeting. A proposed transfer resolution and certificate is attached.

The four bond and MCC programs have help nearly 900 families purchase their first home. These programs have resulted in \$148 million dollars of mortgage loan activity, provided over \$4.2 million dollars in down payment assistance grants, and \$3.1 million dollars in tax savings.

I've saved the best for last. In the next few weeks NRHA is implementing a new bond program that will provide down payment assistance in the form of a grant, and, for the families that qualify within income and purchase price limits, will be able to also use the MCC program. A description of the new program is also attached. Before the summer is over I will be coming to your community to provide a complete overview of our newest program.

We would like to thank Carson City for your ongoing support of the transfer matching fund program. From 1988 to 2005 you were unable to use this allocation. The transfer/matching funds program not only returns the allocation in the form of mortgages for first time homebuyers, but you receive matching funds, a tremendous return on investment.
