WHEREAS, this incidental expense is necessary to ensure the Redevelopment Plan's objectives have been met; and

WHEREAS, the incidental expense is minor compared to the funds needed for the overall Redevelopment Plan.

NOW, THEREFORE, BE IT RESOLVED that the Carson City Board of Supervisors hereby authorizes the expenditure of \$12,000 from the Revolving Fund of the Redevelopment Agency for the support of the Ghost Walk special event in Carson City.

TRANSITION PLAN OBJECTIVES

- 1. Retain the talent, history, core artistry and design of the Carson City Ghost Walk while continuing to create an event that will attract out of town visitors and the pride and participation of the community.
- 2. Allow the CCVB and Redevelopment agency to offer expertise and suggestions and to council to the organization of the Ghost Walk without taxing the time or employees of the afore mentioned organizations. A one-hour meeting should be sufficient. It is also the goal of to maintain communication between The Carson City Ghost Walk and community agencies in Carson City to assure promotion, collaboration and success for all parties.
- 3. Transition from RDA/City Funds so that the Ghost Walk can support itself. In 2012 Ghost Walk will work to secure business support in the form of advertising to offset the costs of the walk. Also as the walk is transitioned, the costs and budget are being accessed to create a walk that is independent of city funds. It is our hope to utilize community calendars, Public Service Announcements and word of mouth to offset any lost marketing and advertising funding.

TRANSITION SCHEDULE

The transition of the Carson City Ghost Walk to Mary Bennett is active immediately. Bennett is currently working on the October 22, 2011 walk.

A meeting is scheduled the third week of August with The Brewery Arts Center (John and **Error! Reference source not found.**) to explore partnering possibilities.

Volunteer lists from past walks will be shared with Bennett via Joy Evans at CCVB.

Redevelopment Special Event Funding Requests for Ghost Walk

On June 16, 2011, the Redevelopment Authority (RDA) and Board of Supervisors approved Redevelopment funding for various special events for fiscal year 2011-12. One of the applications approved was from the Carson City Convention and Visitors Bureau (CVB) for the Ghost Walk event. The RDA and Board of Supervisors approved the request subject to the CVB Board of Directors approving the CVB to run the event, based upon a recommendation from the CVB Special Events Committee.

On July 11, 2011, at a meeting of the CVB Board of Directors, a motion for the CVB to <u>not</u> continue running the Ghost Walk event failed by a vote of 2-2. There was no vote approved for the CVB to run the Ghost Walk event. Therefore, the Redevelopment Agency will not fund the CVB for the Ghost Walk event, per the RDA's and Board of Supervisors' condition of funding approval.

An application for the Redevelopment funds to run the Ghost Walk has been submitted by Mary Bennett, who has been running the event for the CVB over that past years. The request is for the \$12,000 that was originally allocated to the CVB.

The Redevelopment Authority Citizens Committee and CVB Special Events Committee recommended approval of funding for the continuation of the Ghost Walk event this year. The Special Events Committee, however, generally wanted CVB staff to focus on other marketing and events efforts and, therefore, would like someone other than CVB staff to run the event.

History of the event

In 1994 Mary Walker, who was Carson City's Finance Director as well as the Director of the Redevelopment Authority collaborated with Candy Duncan to develop the Kit Carson Trail Blue Line Walking Tour. The goal being an excellent way to showcase Carson City's unique history and to encourage visitors to make time to stop in Carson City to enjoy the rich history and enjoy the downtown businesses. Work ensued to produce a full color blue line map patterned after the Freedom Trail in Boston, Mass. In June of 1995 the inaugural-guided walking tour was held, named the Wild West Tour with the purpose to promote the new blue line and the map. The event was so successful that it was decided to make it an annual event. The following year the tour was moved to Memorial Day weekend to provide activity for visitors and locals alike to keep them in town during the holiday weekend. In October of the following year we produced the first Ghost Walk to take advantage of all the wonderful ghost stories we heard while researching the Kit Carson Trail. Overt the years the Ghost Walk, Wild West Walk and Ghost Walking Tours have enjoyed a strong partnership with the Redevelopment Authority, local business and residents in producing these events.

With the financial support of Redevelopment The Talking House CD's were also produced. Redevelopment has also taken on the responsibility of keeping the Blue Line painted, of sidewalk maintenance when needed and providing signage for the historic homes featured on the trail.

The agencies involved had been uniquely intertwined for the past 15 years in the development and production of the guided walks and marketing aided by Mary Bennett, local producer and Theatre Artist. These partnerships have resulted in a well-known, integral part of Carson City's image and culture. The Kit Carson Trail, boosted by these tours, is now one of our community's most famous attractions.

While different promoters have been contracted in the past to help with the logistics of the guided walks, the CCVB has in the past worked with the promoters. This year Mary Bennett will be the main producer, utilizing relationships with businesses and volunteers from past walks and drawing from her 15 years of experience with the walks as an performing artist, writer, researcher and producer of the walks. The walks utilize local volunteers and actors both from Carson City, Virginia City and Reno bringing together a uniquely qualified and talented group. The tours charge a reasonable fee for the walks helping offset fees for marketing, costuming, printing, artists and other reasonable expenses.

Bennett has worked and collaborated with the organizers of the walk and brings experience in working with volunteers, businesses, artists and production of large events. Bennett has worked locally and regionally as an entertainer and producer for over 20 years and is currently the Producing Artistic Director of Brüka Theatre celebrating 19 years in Reno this season. Bennett is also studying history at TMCC and brings and appreciation and curiosity to our local history, lore and the art of street and live performance, accompanied by 20 years as a local active resident of Carson City and Reno. Bennett currently leads a summer evening Ghost Walking Tour one Saturday a month during the summer during the last two summer seasons from May - September. They are well attended and bring in small groups from out of town to attend the walks. Those groups usually stay in Carson City and travel to Virginia City, sometimes riding the V&T Train. The history buffs have made Carson City a popular stop because of the historic entertaining arts events but also for the well preserved West side that Carson City prides itself on preserving and celebrating its past which is a big reason why the editors of True West magazine recently named it the "Best Western Historical Site."

Usually 25 – 50 volunteers are recruited from the community to serve as guides and docents for the guided walking tours. Scripts are written and actors are hired to portray costumed characters from Carson City's past. The history is dense and the impact on people so strong when they are treated to the stories tied to Abe Curry who gives the inspiration that one man can make a difference. The focus of the walks is historical entertainment with appreciation to the community it has grown out of. Bennett also works with the students from Carson High School for additional characters in the walk who get the opportunity to work beside professional theatre artists. Bennett plans the routes and chooses the theme each year as each year plays off information from Carson City's past while remaining fresh and innovative.

The October Ghost Walk has always been very successful for both the walk and downtown businesses. If funded the Ghost Walk will be scheduled for Saturday October 22, 2011 beginning at 10 am and running every half an hour until 3 pm. We plan to do a total of 22 tours, which will begin on Third Street adjacent to the Firkin and Fox. We look to the downtown businesses to partner with the walks and help create business visits with coupons and flyers. Marketing will be featured in the Nevada Appeal, Regional News & Reviews, and Radio Station's in northern California and Nevada. We are requesting funding from the Redevelopment Authority in the amount of \$12,000. The financials from past years events are enclosed.

I hope that the Redevelopment Authority will continue to partner in bringing this unique and quality event that showcases our beautiful downtown historic district and our attractive downtown. The Ghost Walk enhances our image and is a benefit to all of Carson City and our region. Thank you for your consideration.
