Subject Title: For Possible Action; Action to adopt, on second reading, Bill No. 119 AN ORDINANCE AMENDING TITLE 12, WATER, SEWERAGE AND DRAINAGE, CHAPTER 12.12, SOLID WASTE MANAGEMENT, SECTION 12.12.047, LANDFILL RATES AND FEES, BY LOWERING THE FEE FOR OUT-OF-COUNTY CLASS III, ADDITIONALLY, THE MINIMUM FEE FOR THIS CATEGORY IS LOWERED TO \$20.00 FROM THE EXISTING \$30.00, EFFECTIVE OCTOBER 21, 2011, AND OTHER MATTERS PROPERLY RELATED THERETO. Staff Summary: Staff recommends that the Board of Supervisors consider a decrease in the tonnage rate for out-of-county Class III (inert) waste. The fee for this category had an unanticipated effect on the customers that haul this type of material from out-of-county. A decrease to the proposed \$36.50 per ton versus the existing \$58.00 per ton will regain this customer base. Correspondingly, the minimum fee for this category is proposed to be lowered to \$20.00 from the existing \$30.00.

Recommended Board Action: I move to adopt, on second reading, Bill No. 119, AN ORDINANCE AMENDING TITLE 12, WATER, SEWERAGE AND DRAINAGE, CHAPTER 12.12, SOLID WASTE MANAGEMENT, SECTION 12.12.047, LANDFILL RATES AND FEES, BY LOWERING THE FEE FOR OUT-OF-COUNTY CLASS III, ADDITIONALLY, THE MINIMUM FEE FOR THIS CATEGORY IS LOWERED TO \$20.00 FROM THE EXISTING \$30.00, EFFECTIVE OCTOBER 21, 2011, AND OTHER MATTERS PROPERLY RELATED THERETO.

Explanation for Recommended Board Action: The fee for this category which resulted from consolidation of the rates had an unanticipated effect on the customers that haul this type of material from out-of-county. Consequently, they began disposing of this waste at other facilities. A decrease to \$36.50 per ton as proposed versus the existing \$58.00 per ton will regain the majority of the customer base. Correspondingly, the minimum fee for this category is proposed to be lowered to \$20.00 from the existing \$30.00. Staff met with Empire Contractors and Trashco, both of which haul Class III material to the Carson City Landfill from out of county to hear their concerns. It was agreed that at the rate of \$36.50 they would again bring this waste to the Carson City Landfill. Additionally, staff spoke to South Tahoe Refuse who also delivers this material to the landfill, it is our understanding, at this time, that this waste stream will also return at the proposed rate.

THE BOARD OF SUPERVISORS OF CARSON CITY DO ORDAIN:

SECTION I: That Section 12.12.047 of is hereby amended as follows:

To receive Carson City residential rates, the landfill customer must show proof of residency.

rate for the most expensive material. EXAMPLE: a load is predominately Class III but contains any amount of asbestos containing material, the complete load will be charged at the rate for asbestos.
