On behalf of Carson City, I'd like to express my support of the application for funding under the TIGER III Discretionary Grant program for the Historic V&T Railway Reconstruction Project (Eastgate Station 1 Improvements) in Carson City, Nevada.

The V&T Railway is an important piece of Carson City history and an integral part of the community's future success as a tourism destination. The V&T Railway reconstruction effort is one of the most significant attempts to boost local tourism in recent history.

This project is a major public/private partnership venture with significant support and participation from multiple agencies and organizations. In fact, this project is considered to be so important for the region that voters in Carson City and Storey County passed tax measures, totaling \$23 million, to benefit the project.

Data released in August 2011 indicates that Nevada is continuing to suffer from an incredibly high unemployment rate of 13.4%. All of the counties in the region surrounding the V&T, including those it runs through, have a 24-month unemployment rate higher than the national average, which qualifies them as "Economically Distressed Areas."

Our region is in desperate need of economic reinforcement and the V&T Railway promises to be a major provider – creating approximately 790 full-time jobs within the region.

I urge you to consider this project among the highest priorities for economic recovery so that the citizens of Carson City and the surrounding region can finally begin to feel the economic benefits that the V&T Railway intends to produce.
