The annual report includes the following:

- On February 7, 2011, a show cause hearing was held before the Hearings Examiner, Lee Plemel in regards to Sierra Wine's 3rd Administrative Citation. A seven (7) day suspension of the business's liquor license and a \$1500.00 fine was imposed. Sierra Wines has since gone out of business effective November 2011.
- On August 9, 2011, an appeal form was submitted to the Business License Division by Foodmart 1 located at 1102 N. Carson St. and a letter was written by Jennifer Pruitt, Acting Planning Director in response to the appeal form. The appeal form was denied because it was not submitted within 15 days of the citation being imposed.
