CDBG Funding Allocations - Meeting of March 15, 2012, Item 21(A)

The Planning Division received the final CDBG funding allocation amount today. The total allocation is \$153 less than the HUD estimates that were used and are shown in the Board of Supervisors packets. Total funding in the various categories have been adjusted as follows:

Public Services:	\$ 53,245	\$ 53,223	\$ 22
Public Facilities:	\$266,732	\$266,633	\$ 99
Planning & Admin:	\$ 70,994	\$ 70,964	\$ 30

The attached spreadsheet shows the CDBG application requests for funding and recommended grant allocations with the revised allocations. The recommended project allocations were revised by staff based upon the discussion and recommendations of the application review workgroup.

Also note that the attached spreadsheet includes the relative ranking of the various projects as ranked by the application review workgroup. We will use the spreadsheet at the Board of Supervisors meeting to write in any alternative funding scenarios that the Board offers for consideration and final approval.
