NOTICE OF HEARING AND OF INTENTION TO AUTHORIZE A MEDIUM TERM OBLIGATION BY THE CITY OF CARSON CITY, NEVADA

Notice is hereby given that the Board of Supervisors of the Cily of Carson City, Nevada (the "Board" and "Cily", respectively) will hold a public hearing at a regular meeting to be held at 8:30 a m. on Thursday, May 17, 2012 in the Community Center Sierra Room, 851 East William Street, Carson Cily, Nevada, to act upon a resolution authorizing a medium-term obligation of the City in the maximum principal amount of \$1,100,000 to enable the Board to finance the cost of ambulances, wheel chair vans, and improvements and equipment for the City land till (the "Project").

The medium-term obligation is not proposed to be repaid in whole or in part by the levy of a tax exempt from the limitations on taxes ad vatorem, but is to be repaid from legally available funds of the City, including, without limitation, monies deposited in the City's capital projects fund in an estimated annual amount of \$233,500, and other legally available monies, including ad vatorem taxes levied within the limitations provided in Chapter 354 of the Nevada Revised Statutes.
