Subject Title: For Possible Action: To adopt a resolution authorizing the expenditure of up to \$26,275 from the Redevelopment Revolving Fund for Fiscal Year 2012/13 to support various special events in the Redevelopment District as an expense incidental to the carrying out of the redevelopment plan. (Lee Plemel)

Staff Summary: The Redevelopment Authority and Board of Supervisors approved Redevelopment special event funding on April 5, 2012, in the amount of \$92,000 for FY 2012/13. \$100,000 was budgeted for special events and there was \$118,275 in special event funding requests. The Redevelopment Authority asked City staff to bring the item back to them after the FY 2012/13 budget was adopted to determine if additional funds are available to provide additional funding to special events. The additional special event funding that was requested but not previously approved is \$1,000 for the Silver Dollar Car Classic, \$4,000 for RSVP events (4th of July Fair, Nevada Days Fair and Spring Fun Fair), \$500 for the Farmers Market, \$4,500 for Nevada Day, \$1,275 for Silver & Snowflakes Holiday Tree Lighting, and \$15,000 for the June 2013 Carson City Rendezvous.

NRS 279.628 permits the expenditure of money from the redevelopment revolving fund for the purpose of any expenses necessary or incidental to the carrying out of the redevelopment plan adopted by the Carson City Board of Supervisors. Pursuant to NRS 279.628, this Resolution must be adopted by a two-thirds vote of the Board of Supervisors.

A RESOLUTION AUTHORIZING THE EXPENDITURE OF UP TO \$26,275 FROM THE REDEVELOPMENT REVOLVING FUND FOR FISCAL YEAR 2012/13 TO SUPPORT VARIOUS SPECIAL EVENTS IN THE REDEVELOPMENT DISTRICT AS AN EXPENSE INCIDENTAL TO THE CARRYING OUT OF THE REDEVELOPMENT PLAN.

WHEREAS, pursuant to NRS 279.628, the Carson City Board of Supervisors must approve by resolution, adopted by a two-thirds vote, the expenditure of money from the Revolving Fund for the Redevelopment Authority for any expenses incidental to the carrying out of the Redevelopment Plan adopted by the Carson City Board of Supervisors; and

WHEREAS, the Redevelopment Plan for Redevelopment Project Area No. 1 encourages redevelopment assistance for daytime and evening special events and promotional activities and the highest level of recreational opportunities for residents and visitors of all age levels and thus, there is a casual connection between this redevelopment effort and the need for this expenditure; and

WHEREAS, this incidental expense is necessary to ensure the Redevelopment Plan's objectives have been met; and

WHEREAS, the incidental expense is minor compared to the funds needed for the overall Redevelopment Plan.

NOW, THEREFORE, BE IT RESOLVED that the Carson City Board of Supervisors hereby authorizes the expenditure of up to \$26,275 from the Revolving Fund of the Redevelopment Authority for the support of the following special events in Carson City:

RSVP Fairs: \$4,000 Farmers Market: \$500 Nevada Day: \$4,500

Arlington Group Events: \$1,275

Nevada Shows (Silver Dollar Car): \$1,000 Nevada Shows (Rendezvous): \$15,000

Consideration of approving additional funding for Redevelopment Special Event

requests for FY 2012-13

The Redevelopment Authority and Board of Supervisors approved funding for Redevelopment special events on April 5, 2012. This approval occurred before the final Redevelopment budget was approved, and the estimated budget for special events could not fully fund all of the special event requests. Attachment A shows the special event funding that was approved. The Redevelopment Authority/Board of Supervisors directed staff to come back after the FY (Fiscal Year) 2012/13 budget was finalized to determine if there are additional funds available to supplement the approved special event funding.

A total of \$100,000 was budgeted for Redevelopment special events in FY 2012/13. Special event funding requests totaled \$118,275, and the Redevelopment Authority and Board of Supervisors authorized \$92,000 in expenditures for special events, leaving \$26,275 in special event funding requests that were not funded.

The adopted FY 2012/13 Redevelopment budget includes \$77,876 for undesignated infrastructure projects—essentially Redevelopment revenue that is remaining after funding other budget obligations. A portion of this funding could be redirected to fund any shortfall in special event funding. Refer to Attachment B for the Redevelopment FY 2012/13 budget.

Following is a summary of the special event applications that were not fully funded.

1. Applicant: Nevada Rural Counties RSVP Program

Event: 4th of July, Nevada Day, and Spring Fair events

Description: 4th of July fireworks, carnivals, arts, crafts, novelties, and food vendors during these

three events throughout the year.

Requested funding: \$25,000 Approved funding: \$21,000

Difference: \$4,000

Applicant: Linda Marrone

Event: 3rd & Curry Street Farmers Market

Description: Downtown farmers market, June 9-September 22.

Requested funding: \$15,000 Approved funding: \$14,500

Difference: \$500

3. <u>Applicant</u>: Nevada Day, Inc. Event: Nevada Day Celebration

Description: Annual Nevada Day Parade and associated events including the Governor's

banquet dinner, and rock drilling, beard, and pine derby contests.

Requested funding: \$25,000 Approved funding: \$20,500

Difference: \$4,000

4. <u>Applicant</u>: Arlington Group Events, LLC Event: Silver & Snowflakes Festival of Lights

Description: Annual Christmas Tree lighting event at the Capitol Building and City Tree, and

including special activities in the Downtown.

Requested funding: \$9,275 Approved funding: \$8,000

Difference: \$1,275

5. <u>Applicant</u>: NV Shows, LLC Event: Silver Dollar Car Classic

Description: Annual downtown three-day car show, including live music of the 50's, 60's, and

70's, show-n-shines, food, and cruising.

Requested funding: \$5,000 Approved funding: \$4,000

Difference: \$1,000

6. <u>Applicant</u>: NV Shows, LLC Event: Carson City Rendezvous

<u>Description</u>: Annual Carson City Rendezvous event at Mills Park, showcasing the great history of our state and of the Old West that was settled by the pioneers who founded this region.

Requested funding: \$15,000

Approved funding: \$0 (\$8,000 was approved from the 2011/12 budget for the June 2012 event.)

Difference: \$15,000

The Redevelopment Authority and Board of Supervisors may authorize the use of the budget for undesignated infrastructure improvements within the Redevelopment Revolving Fund to fund a portion of or all of the unfunded amount of the above special event requests. The funding is available for this use, but any reallocated to special events will result in a reduction in available funds for other infrastructure projects within the Redevelopment Area.
