Preparing clients for job readiness








- Unadoptable: these cats may exhibit aggressivness; behavior issues or have a complicated medical condition that causes them to be unadoptable.
- Occassionally, we may be out of space and no rescue groups








Animal Services

Animal Services is required by the ordinance to accept from the public any stray dog, and to respond to any call/complaint of a stray dog and impound such a dog if found.





Animal Services makes every effort to reunite lost dogs with their owners. Even through lost and found reports and scanning for microchips, our return to owner rate is only around 50%. As with cats, all dogs adopted from the shelter receive a microchip at the time of adoption.

Animal Services will euthanize dogs for the following reasons:

- Sick or injured severely enough to be declared untreatable by the shelter veterinarian.
- Unadoptable: may include aggressiveness or behavior issues that are inappropriate for adoption. May also include complicated medical conditions.




Disease Investigation


Diseases in the community are tracked when reported. The largest volume of reports in our community are STD's.

Comparison of chlymdida rates for Carson City, State of Nevada and U.S. These rates are per 100,000 population, for all age groups.

Carson City is lower then both Nevada and the U.S., however we have observed an increase in our rates, since 2009.


Timely treatment for STDs is important in reducing new cases of STDs in the community.

CCHHS clinic has decreased the average number of days it takes to treat patients who are positive for STDs.




Environmental Health

Inspections are conducted via a risk based system; the more advanced food preparation the higher frequency of inspections. Inspections range from 1-4 times per year.



Critical violations are violations that increase the risk of foodborne illness or life safety issues. Critical violations are grouped into three categories, food, personal, and facility. Critical food violations could be food out of temperature or not from an approved source. Critical personal violations could be sick employees at work or employees not washing hands. Critical facility violations could be sewage leak





This is a breakdown of all violations found in food establishments each month. The violations are grouped by critical vs. non-critical. Each group has three categories, food, facility and personal.




Community Health Clinic

Vaccinations continues to be the most frequent service provided by the Community Health Clinic.










Targets for these measures represent the case load reported over a prior 6 month period.





CDC Public Health Emergency Preparedness

To assist state and local public health departments in their strategic planning, CDC developed 15 capabilities to serve as national public health preparedness standards and CCHHS performs tasks in the following areas to help us meet one or more of these capabilities.


