Hi Romane,

Just a follow up on our call this afternoon- The state Immunization Program will be providing a subgrant to CCHHS to provide flu immunizations and Hep A/B or Twinrix to the inmate population at the Carson City Jail. The subgrant will also include the ability for CCHHS to purchase mental health medications as indicated by diagnosis for the inmate population.

This is a \$41,000 grant that will need to be expended over the next two years. CCHHS can expend the funds as needed. A monthly reporting form will need to be sent back to the program so that we can track the numbers served by the settlement funds (reporting will end when the funds are spent down and all appropriate medications and immunizations have been administered).

We expect the authority to spend the funds next week and subgrants will be executed within the following weeks after we have the authority.
