#### GRANT OF EASEMENT

CARSON CITY, A CONSOLIDATED MUNICIPALITY OF THE STATE OF NEVADA ("Grantor") for One Dollar (\$1.00) and other and good valuable consideration, receipt of which is hereby acknowledged, grants and conveys to SIERRA PACIFIC POWER COMPANY, a Nevada corporation, d/b/a NV Energy ("Grantee"), its successors and assigns, a perpetual right and easement:

- to construct, operate, add to, modify, maintain and remove aboveground and/or underground communication facilities and electric line systems for the distribution and transmission of electricity, consisting of poles, other structures, wires, cables, conduit, duct banks, manholes, vaults, transformers, service boxes/meter panels, cabinets, bollards, anchors, guys, and other equipment, fixtures, apparatus, and improvements ("Utility Facilities") upon, over, under and through the property described in <a href="Exhibit "A" and depicted in Exhibit "B" hereto and by this reference made a part of this Grant of Easement ("Utility Easement Area");</a>
- for the unrestricted passage of vehicles and pedestrians within, on, over and across the
  property described in Exhibit "C" and depicted in Exhibit "D" ("Access Easement Area")
  and the "Utility Easement Area."
- 3. for ingress of vehicles and pedestrians to and the egress of vehicles and pedestrians from the "Utility Easement Area" and "Access Easement Area;" and
- 4. to remove, clear, cut or trim any obstruction or material (including trees, other vegetation and structures) from the surface or subsurface of the Easement Area as Grantee may deem necessary or advisable for the safe and proper use and maintenance of the electric line systems and communication facilities in the Easement Area.

Grantee will be responsible for any damages, proximately caused by Grantee negligently constructing, operating, adding to, maintaining, or removing the Utility Facilities, to any tangible, personal property or improvements owned by Grantor and located on the Easement Area on the date Grantor signs the Grant of Easement. However, this paragraph does not apply to, and Grantee is not responsible for, any damages caused when Grantee exercises its rights under numbered paragraph 4 above.

Grantor covenants for the benefit of Grantee, its successors and assigns that no building, structure or other real property improvements will be constructed or placed on or within the Utility Easement Area without the prior written consent of Grantee, such structures and improvements to include, but not limited to drainage, trees, bridges and signage. Grantee and Grantor must document Grantee's consent by both signing

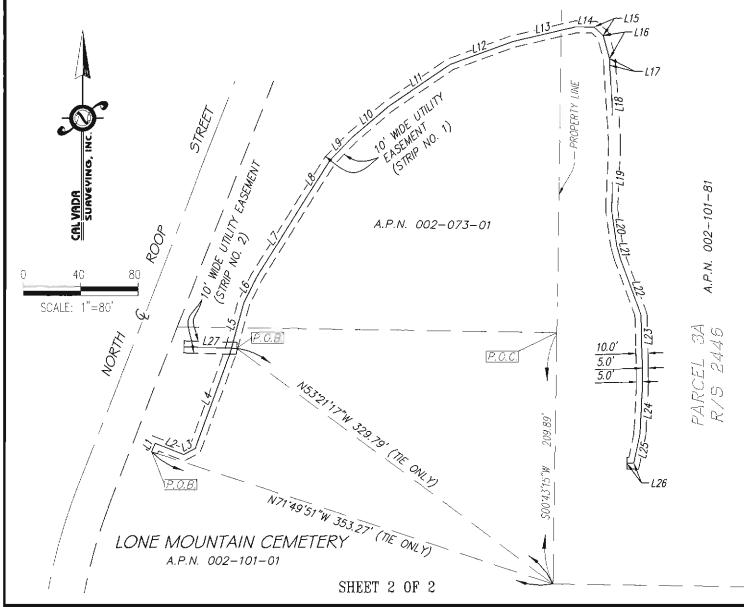
