Staff Summary: This action will result in the addition of one FTE within the Sheriff's Office, and therefore requires Board approval. This request was discussed and recommended at Internal Finance Committee meeting held December 4, 2013.

Recommended Board Action: I move to convert a Captain position to two deputy sheriff positions within the Sheriff's Office.		
Explanation for Recommended Board Action: This action item is required due to a recommendation to deviate from the current FY2014 budget authorizations, and result in one additional total sworn position's in the Sheriff's Office. In December 2013, one of four Lieutenant/Captain managerial positions at the Sheriff's Office retired from service. Following an internal review of the vacancy, it was determined that the department was authorized a sufficient number of managers to division ratio without filling the vacancy. The review also highlighted a shortage of two deputy sheriff positions within the detention facility to meet minimum requirements in accordance with collective bargaining agreement staffing levels. Since 2010, the jail has operated with 21 front line employees, while 23 are necessary to meet staffing. This results in voluntary and mandatory overtime to fulfill needs. The conversion of one lieutenant/captain position to two deputy positions will result in two new frontline positions authorized for the detention facility and a reduction of one department managerial position. This action item has been presented to the city Internal Finance Committee and received a recommendation to proceed to the Board of Supervisors for approval.
