Subject Title: For Possible Action: To reject Herback General Engineering's Bid Protest based on the determination that Sierra Nevada Construction, Inc. did follow Bid Proposal procedures and was the lowest responsive responsible bidder.

Staff Summary: Carson City received sealed bids for all labor, material, tools and equipment necessary for the Costco Intertie and Vista Grande Waterline Project. Herback General Engineering protested the award to Sierra Nevada Construction, Inc. and the award was stayed. Staff is recommending rejection of Herback General Engineering's Bid Protest.

Recommended Board Action: I move to reject Herback General Engineering's Bid Protest based on the determination that Sierra Nevada Construction, Inc. did follow Bid Proposal procedures and was the lowest responsive responsible bidder.

Explanation for Recommended Board Action: A Notice of Protest received from Herback General Engineering on March 14, 2014, stating that they (Sierra Nevada Construction, Inc.) did not comply with the "good faith effort" by not placing an advertisement in the SBA and Minority Business Development Agency of the Department of Commerce. After review by staff, regarding good faith effort and DBE/MBE/WBE contract goals, staff determined that Sierra Nevada Construction, Inc. did demonstrate good faith effort in meeting the DBE/MBE/WBE contract goal for this project. Sierra Nevada Construction, Inc., met five (5) of the proposed eight (8) goals for the DBE/MBE/WBE goals and further, in addendum 2 of the 1314-142 bid it clearly states " If the contract goal is not met, evidence of good faith efforts must be attached." Therefore, staff is recommending rejection of bid protest.






Bid Addendum #1 requires bidders to make six "Good Faith Efforts" in fulfilling the DBE participation goal for the project. Upon review of bids, it is apparent that only 4 of 9 bidders complied with six Good Faith Efforts. Specifically:

5. Use the services and assistance of the SBA and Minority Business Development Agency of the Department of Commerce
6. If the prime contractor awards subcontracts, require the prime contractor to take the above steps

Bidders that complied with this provision are Campbell Construction, Burdick Excavating, Reno Tahoe Construction and Herback General Engineering. It is the opinion of Herback General Engineering that all other bidders are non responsive in regard to this provision. Your review and consideration is requested in this matter prior to award of the Contract.

Dear: Mr. Griffin:

I am in receipt of your "Bid Protest, Bid #1314-142, Costco Intertie & Vista Grande Waterline". After a thorough review of your concerns stated in the Notice, it has been determined that the low bidder is in compliance with the requirements of DBE participation goal and the "Good Faith Efforts"

1) Use the services and assistance of the SBA and Minority Business Development Agency of the Department of Commerce. In the Bid Response from SNC they attached a copy of a "Request for Sub-Quotes" and at the bottom of the page indicated that an e-mail blast of the attached document from the Nevada Governor's Office of Economic Development went out to DBE/WBE Subcontractors and Suppliers. Through the Governor's Office of Economic Development (GOED) they have implemented a new Local Emerging Small Business Program since the passage of AB294 in the 2013 Legislature. Also, SNC advertised in the Minority Focus Journal and attached a copy of ad. Through discussion with NDEP the above documentation meets the requirements for the "Good Faith Efforts". Also, in SNC's Bid Response on page BP-19 (Addendum #3 attachment), SNC has listed their DBE/MBE/WBE goals and they will meet five of the eight Goal requirements. Herback General Engineering's Bid Response page BP-19 clearly states that none of the goals for DBE/MBE/WBE were met.

Based on Addendum No. 1 recipients of EPA financial assistance are required to seek and utilize small, minority and women owned businesses. Addendum No. 2 of the 1314-142 Costco Intertie Bid clearly states that the intent of "Good Faith Effort" is to provide evidence of good faith efforts if the DBE/MBE/WBE goal is not met. Please see the following excerpts from Addendum 1 and Addendum 2:

Page 2 of 6 of Addendum 1:

"Recipients of EPA financial assistance agreements are required to seek, and encouraged to utilize small, minority, and women-owned businesses for their procurement needs under the financial assistance agreement."

Page 3 of 6 of Addendum 1:

"Fair Share Objectives

A fair share objective is a goal based on the capacity and availability of qualified, certified MBEs and WBEs in the relevant geographic market for the grant recipient in

the procurement categories of construction, equipment, services, and supplies... compared to the number of all qualified entities in the same market for the same procurement categories."

Page 1 of 4 of Addendum 2 last sentence:

"If the contract goal is not met, evidence of good faith efforts must be attached."

2) If the prime contractor awards subcontracts, require the prime contractor to take the above steps. Please see response to 1).

Staff believes the above resolves your concerns, if not we will schedule the protest for the April 3, BOS meeting.



1. Replace "**CONTRACTOR'S LICENSE:**" paragraph on page NC-2 with the following:

"CONTRACTOR'S LICENSE This is a Federal-aid contract and the requirements for such shall apply. On a Federal-aid contract, any Contractor otherwise qualified by the State of Nevada to perform such work is not required to be licensed nor to submit application for license in advance of submitting a bid or having such bid considered, provided, however, that such exception does not constitute a waiver of the State's right under its license laws to require a Contractor, determined to be a successful bidder, to be licensed to do business in the State of Nevada in connection with the award of the contract to him.

2. Insert the following section in the Instructions to Bidders Page ITB-2 and ITB-3 Section E. **Bid Preparation and Submission:**

2.5 This is a Federal-aid contract and the following provisions need to be followed:

The Environmental Protection Agency (EPA) Office of Small Business Programs (OSBP) Disadvantaged Business Enterprise Program – 40 CFR Part 33

Formerly the Minority-Owned Business Enterprise and Woman-Owned Business Enterprise (MBE/WBE) Program, the Disadvantaged Business Enterprise (DBE) Program is an outreach, education, and goal program designed to increase and encourage the utilization and participation of DBEs in procurements funded by EPA assistance agreements. The DBE Program requirements apply to all procurements for equipment, supplies, construction and services under all EPA grants, cooperative agreements, and IAGs.

The contractor shall not discriminate on the basis of race, color, national origin or sex in the performance of this contract. The contractor shall carry out applicable requirements of 40 CFR part 33 in the award and administration of contracts awarded under EPA financial assistance agreements. Failure by the contractor to carry out these requirements is a material breach of this contract which may result in the termination of this contract or other legally available remedies.

Specific DBE Program functions include:

- Developing and monitoring DBE Program policy and procedures.
- Providing outreach and training to internal and external DBE program stakeholders.
- Providing technical and programmatic assistance to minority and women-owned businesses.
- Collecting, compiling, and analyzing data on MBE/WBE utilization under EPA financial assistance agreements, including Interagency Agreements (IAs).

Recipients of EPA financial assistance agreements are required to seek, and encouraged to utilize small, minority, and women-owned businesses for their procurement needs under the financial assistance agreement. This is done through the inclusion of terms and conditions in the financial assistance agreement. The key functional components of the DBE Program are as follows:

- Fair Share Objectives
- Six Good Faith Efforts and Contract Administration Requirements
- MBE/WBE Reporting
- MBE/WBE Certification

Disadvantaged Business Enterprises (DBEs) are:

- entities owned and/or controlled by a socially and economically disadvantaged individuals as described by Title X of the Clean Air Act Amendments of 1990 (42 U.S.C. 7601 note) (10% statute), and Public Law 102-389 (42 U.S.C. 4370d) (8% statute), respectively;
- a Small Business Enterprise (SBE);
- a Small Business in a Rural Area (SBRA);
- a Labor Surplus Area Firm (LSAF); or
- a Historically Underutilized Business (HUB) Zone Small Business Concern, or a concern under a successor program.

Minority Business Enterprises (MBEs) are entities that are at least 51% owned and/or controlled by a socially and economically disadvantaged individual as described by Title X of the Clean Air Act Amendments of 1990 (42 U.S.C. 7601 note), and Public Law 102-389 (42 U.S.C. 4370d), respectively.

Women's Business Enterprises (WBEs) are entities that are at least 51% owned and/or controlled by women (under the 10% and 8% statutes).

Fair Share Objectives

A fair share objective is a goal based on the capacity and availability of qualified, certified MBEs and WBEs in the relevant geographic market for the grant recipient in the procurement categories of construction, equipment, services, and supplies... compared to the number of all qualified entities in the same market for the same procurement categories.

- A fair share objective is not a quota.
- A recipient cannot be penalized for not meeting its fair share objectives.
- Once negotiated, fair share objectives remain in place for three years.

Good Faith Efforts

The Good Faith Efforts are required methods employed by all EPA financial assistance agreement recipients to ensure that all disadvantaged business enterprises (DBEs) have the opportunity to compete for procurements funded by EPA financial assistance dollars.

The Six Good Faith Efforts Are:

1. Ensure DBEs are made aware of contracting opportunities to the fullest extent practicable through outreach and recruitment activities. For Indian Tribal, State and Local and Government recipients, this will include placing DBEs on solicitation lists and soliciting them whenever they are potential sources.
2. Make information on forthcoming opportunities available to DBEs and arrange time frames for contracts and establish delivery schedules, where the requirements permit, in a way that encourages and facilitates participation by DBEs in the competitive process. This includes, whenever possible, posting solicitations for bids or proposals for a minimum of 30 calendar days before the bid or proposal closing date.
3. Consider in the contracting process whether firms competing for large contracts could subcontract with DBEs. For Indian Tribal, State and local Government recipients, this will include dividing total requirements when economically feasible into smaller tasks or quantities to permit maximum participation by DBEs in the competitive process.
4. Encourage contracting with a consortium of DBEs when a contract is too large for one of these firms to handle individually.

5. Use the services and assistance of the SBA and the Minority Business Development Agency of the Department of Commerce.
6. If the prime contractor awards subcontracts, require the prime contractor to take the above steps.

MBE/WBE Reporting

All EPA financial assistance recipients are required to report back to the Agency on their efforts to comply with the DBE Program requirements.

- Complete & submit EPA Form 5700-52A Part II with each contractor's application for payment.

- **MBE/WBE Certification**

Under EPA's DBE Program it is required that MBEs and WBEs be certified in order for their utilization to count toward an EPA financial assistance recipient's accomplishments under the program.

EPA OSBP Headquarters is responsible for implementing and processing the certification of MBE/WBE firms. Regional DBE coordinators will assist by providing forms to interested firms and fielding general questions. Under the new DBE Program entities can no longer self-certify. EPA will accept certifications from:

- The Small Business Administration (SBA) (both SBA 8(a) program certifications and SBA Small Disadvantaged Business (SDB) Program self-certifications);
- The Department of Transportation's state implemented DBE Certification Program (with U.S. citizenship);
- Tribal, State and local governments, as long as their standards for certification meet or exceed our own; and
- Independent private organization certifications as long as their standards for certification meet or exceed our own.

If an entity holds one of these certifications, it is considered acceptable for establishing MBE or WBE status under EPA's DBE Program, and application for EPA certification is not needed. EPA will ONLY consider certification applications from entities that have first attempted to be certified by SBA or DOT, or a Tribal, State, or local government, or by an independent private organization, and be unsuccessful in that attempt. Proof of an unsuccessful attempt is required as a part of the application process.

What are the EPA MBE/WBE certification requirements?

- In order to be certified by EPA, an entity must first attempt to be certified by SBA or DOT, or a Tribal, State, or local government, or by an independent private organization, and be unsuccessful in that attempt.

- To qualify as a MBE or WBE under EPA's programs an entity must establish that it is at least 51% owned and/or controlled by socially and economically disadvantaged individuals who are of good character and are citizens of the United States.
- An individual claiming economic disadvantaged status must have an initial and continued personal net worth of less than \$750,000.

21. ALL MANHOLES, ACCESS LIDS TO VAULTS, SURVEY MONUMENT CAPS, VALVES BOXES AND LIDS LOCATED WITHIN DOUGLAS COUNTY SHALL BE FLUSH TO THE SURFACE AND HAVE CONCRETE COLLARS AS SPECIFIED IN DOUGLAS COUNTY STANDARD DETAILS DC C08 AND DC B08.

Revise note 8 to read:

8. ALL PAVING SHALL BE PG 64-28 NV. 2" TYPE 3 MIX OVER 2" TYPE 2 MIX.

4. RFI responses:

- Please confirm that either T&G mortared joints or gasketed joints are permitted for bid items BP.46 through BP.50. BP.49 would have to be T&G mortared (or field collared) as these 15" RCP End Sections are not available with gasketed joints. Special Conditions section 3.2.26 A (ppsSC20 and SC21) state items per Secion 306 of City Standard Specs. City Standard Specs appears to allow for either RCP with T&G mortared joints or RCP gasketed joints.*

T&G mortared joints or gasketed joints are permitted for bid items BP.46 through BP.50. BP.49 if all manufacturers' recommendations are followed.

- b. *Please confirm that Fusible PVC™ can be used as an alternate restrained joint option where deemed appropriate by the General Contractor?*

Fusible PVC may be used in place of the 12" C900 pipe if all manufacturers' recommendations are followed. Fusible PVC may be used in place of the 14" C905 only if it used for the entire length of pipe and manufacturers' recommendations are followed. The 14" may not be a combination of standard PVC and Fusible.

304 stainless steel bolts, nuts and washers are required for all buried and submerged work as specified on the standard details and shown on the plans.

8. RFI responses:

- a. *Project documents and drawings refer multiple times to Utility Work Order drawings for work associated with NV Energy. Is the work order drawing / design available for estimating purposes?*

The work order is in process but is not expected to change the work shown on the plans.

- b. *The site At the intersection of Clearcreek and Vista Grande is currently surrounded by F-Rail, I believe belonging to Carson City. Will the Contractor be required to move that rail, and if so, Where?*

The F-rail will be removed by Carson City prior to construction.

- c. *The Geotech Report references a building, and an intersection re-alignment. We don't find either.*

The Geotech Report was prepared based on a different project approach, there is no building and no road realignment as part of this project.

- d. *There are no sizes indicated on the (3) air releases on the project. Are all three the standard 3/4"?*

Standard ARVs are to be installed per the City Standard Details.

- e. *Bid schedule item BP.28 calls for NewBasis item FCA400036T-0006, the electrical plans on sheet 21 call for item FCA4000046T-0006. Please verify which one.*

The bid item is correct, Sheet 21 has been updated.

- f. *Bid schedule item BP.24 calls for 1" SCH80 duct, the electrical plans on sheet 22 call for 1.25" duct. Please verify which size.*

The bid item is correct, use the 1" conduit with fiber preinstalled.

- g. *On page SC-26 Paragraph 6.2 it states that "All trench bedding, backfill, structural fill, and aggregate base shall be imported..." "Unless otherwise provided for ...use of materials excavated at the project site will not be allowed". The trench Excavation and Backfill Detail on sheet 23 shows the trench backfill to be Class "E" backfill which is the native*

material with the over 4" material screened out. Also, paragraph 5.4.6 of the Geotechnical Investigation states that "Most native soils will meet the requirements for trench backfill after removal of any oversize material (>4inch diameter)". My question is : Can the native material (with >4" material screened out) be used for the backfill zone in the pipe trenches (and conduit trenches) or do we need to export all trench materials and import backfill material?

If the native material meets the requirements, it will be allowed to be used.

- h. Is there a fog seal required on all paving? This is not usually used in conjunction with polymer oils?*

No fog seal is required.

- i. I see all ac is PG 64-28 NV either Type 2 for bottom lift or type 3 for top lift. Is all of this mix 75 blow? What percent air voids are required? Is lime required?*

All of the mix 75 blow and lime is required. All A.C surfaces shall be compacted to 96% (minimum) Marshall maximum density.

- j. Does the 2150 LF on bid schedule item BP.24 include the 100' coils in each of the two manholes as specified on page SC-16 of the spec book?*

Yes it does.

- k. Just for clarification is this (Addendum #1, Statement #1) stating that the contract must have a Class A general license? or is it stating that as long as long as the contractor has all the subcategories they are ok?*

The general contractor on the project must have a Classification A: General Engineering license to perform the work on the project.
