# Re: BID PROTEST Bid/Contract No. 1314-175 (East West Water Transmission Main Project) Ph. 2A-1

Dear Ms. Belt:

I am writing at this time pursuant to NRS 338.142 to protest Carson City's recommendation to award the above-referenced project to A & K Earth Movers Inc.

As you are aware, bids for this Project were opened on Thursday, May 8, 2014. At the time of the opening of the bids, A & K Earth Movers was the apparent low bidder, with a bid of \$2,037,000. Sierra Nevada Construction, Inc. ("SNC") was the second lowest bidder, with a bid of \$2,043,007.

Carson City's bid documents, at page ITB-8, included the following provision:

### P. Subcontracting

The Bidder agrees that he/she will perform work totaling at least Fifty per cent (50%) of the Bid amount and will not subcontract work totaling more than Fifty per cent (50%) of the Bid amount. The Bidder shall be bound by and comply with NRS 338.141 to limit the practice of shopping for Bids and shall provide a Subcontractors Listing with the submission of their Bid. The form must have the spaces filled in for each subcontractor who will be paid an amount exceeding five percent (5%) of the Bid amount. Within two (2) hours after the opening of Bids, the bidders who submitted the three lowest Bids must submit a list of names of each subcontractor for which he/she will be paid an amount exceeding one percent (1%) of the Bid amount or Fifty Thousand Dollars (\$50,000),

whichever is greater. Within twenty-four (24) hours of the Bid opening the Bidder who submitted the lowest Bid must submit a list of all subcontractors who will perform any work on the Contract, including their name, license number and classification, items of work to be performed and anticipated amount of the subcontract. If a bidder fails to submit such lists within the required time, his/her Bid shall be deemed non-responsive. (emphasis added).

Both SNC and A & K complied with the statutory provisions found in NRS 338.141 with respect to submitting their 5% list and 1% list. However, in addition to the statutory requirements, Carson City's bid specification also included other requirements that were required to be met. Specifically, as noted above, those specifications required that the low bidder submit a list of all subcontractors within 24 hours. Furthermore, the bid specifications expressly provided that "If a bidder fails to submit such list within the required time, his/her bid shall be deemed non-responsive." For this bid, A & K did not submit the required list; however, SNC did submit the proper 24 hour list pursuant to the Bid Documents.

The purpose of these types of provisions is to prevent general contractors from bid shopping after bid award. These provisions are common among many local agencies. Removing these provisions could have a detrimental effect to the integrity of future bids for Carson City.


As you are aware, pursuant to NRS 338.1385, in order for a public agency to accept a bid, it must find that the bidder is "responsive." However, because Carson City's bid documents expressly state that a bidder that does not comply with the subcontractor listing provisions "shall be deemed non-responsive," then, as a matter of law, Carson City may not award this project to the apparent low bidder, which was expressly deemed to be non-responsive because it failed to comply with the bid documents.

Please note that we have reviewed your letter of May 19, 2014 explaining your position. However, with all due respect, I would submit that your analysis in that letter is not relevant to this situation. Clearly, all bidders were required to comply with NRS 338.141. In fact, SNC concedes that the apparent low bidder did comply with that statute. Therefore, that is not the issue here. The issue here is that Carson City, in its bid documents, decided to include <u>additional</u> requirements for bidders. When a public agency issues bid documents that include additional requirements over and above the statutory requirements, so long as those additional requirements are not in conflict with the statutory requirements, then those additional requirements become binding on the bidders. Therefore, the fact that NRS 338.141 does not include provisions to submit a 24-hour list is completely irrelevant to the analysis as to whether a bid that failed to comply with other express requirements is non-responsive.

Pursuant to the terms of its very own specifications, the bid from the apparent low bidder on this Project is "deemed non-responsive." Therefore, it would be a violation of Nevada law for a public agency to award a contract to a bidder that the public agency has expressly identified as non-responsive. As such, please let this serve as formal notice of SNC's protest of any recommendation for award of this Project to the apparent low bidder. Please also let this serve as a request that Carson City award the contract for this Project to SNC, as the lowest responsive and responsible bidder on the Project.

Dear: Mr Markwell:

I am in receipt of your "Bid Protest". As stated before I would like to thank you for bringing to my attention the error in the Instruction to Bidders paragraph P. Subcontracting. After a thorough review of NRS 338.141 it has been determined that the last two sentences of the paragraph are an error in the bid document and are not in compliance with NRS 338.141. Please see complete NRS 338.141 below:

NRS 338.141 Bids to include certain information concerning subcontractors and prime contractors; when bids deemed not responsive with respect to subcontractors; requirements and penalties for substitution of named subcontractors.

1. Except as otherwise provided in NRS 338.1727, each bid submitted to a public body for any public work to which paragraph (a) of subsection 1 of NRS 338.1385, paragraph (a) of subsection 1 of NRS 338.143 or NRS 408.327 applies, must include:

(a) If the public body provides a list of the labor or portions of the public work which are estimated by the public body to exceed 3 percent of the estimated cost of the public work, the name of each first tier subcontractor who will provide such labor or portion of the work on the public work which is estimated to exceed 3 percent of the estimated cost of the public work; or

(b) If the public body does not provide a list of the labor or portions of the public work which are estimated by the public body to exceed 3 percent of the estimated cost of the public work, the name of each first tier subcontractor who will provide labor or a portion of the work on the public work to the prime contractor for which the first tier subcontractor will be paid an amount exceeding 5 percent of the prime contractor's total bid. If the bid is submitted pursuant to this paragraph, within 2 hours after the completion of the opening of the bids, the contractors who submitted the three lowest bids must submit a list containing:

(1) The name of each first tier subcontractor who will provide labor or a portion of the work on the public work to the prime contractor for which the first tier subcontractor will be paid an amount exceeding \$250,000.

(2) If any one of the contractors who submitted one of the three lowest bids will employ a first tier subcontractor who will provide labor or a portion of the work on the public work to the prime contractor for which the first tier subcontractor will not be paid an amount exceeding \$250,000, the name of each first tier subcontractor who will provide labor or a portion of the work on the public work to the prime contractor for which the first tier subcontractor will be paid 1 percent of the prime contractor's total bid or \$50,000, whichever is greater.

(3) For each first tier subcontractor whose name is listed pursuant to subparagraph (1) or (2), the number of the license issued to the first tier subcontractor pursuant to chapter 624 of NRS.

#### Bid Protest Page 2

2. The lists required by subsection 1 must include a description of the labor or portion of the work which each first tier subcontractor named in the list will provide to the prime contractor.

3. A prime contractor shall include his or her name on a list required by paragraph (a) or (b) of subsection 1. If the prime contractor will perform any work which is more than 1 percent of the prime contractor's total bid and which is not being performed by a subcontractor listed pursuant to paragraph (a) or (b) of subsection 1, the prime contractor shall also include on the list:

(a) A description of the labor or portion of the work that the prime contractor will perform; or

(b) A statement that the prime contractor will perform all work other than that being performed by a subcontractor listed pursuant to paragraph (a) or (b) of subsection 1.

4. Except as otherwise provided in this subsection, if a contractor:

(a) Fails to submit the list within the required time; or

(b) Submits a list that includes the name of a subcontractor who, at the time of the submission of the list, is on disqualified status with the Division pursuant to <u>NRS 338.1376</u>,

 $\rightarrow$  the contractor's bid shall be deemed not responsive. A contractor's bid shall not be deemed not responsive on the grounds that the contractor submitted a list that includes the name of a subcontractor who, at the time of the submission of the list, is on disqualified status with the Division pursuant to <u>NRS 338.1376</u> if the contractor, before the award of the contract, provides an acceptable replacement subcontractor in the manner set forth in subsection 1 or 2 of <u>NRS 338.13895</u>.

5. A prime contractor shall not substitute a subcontractor for any subcontractor who is named in the bid, unless:

(a) The public body or its authorized representative objects to the subcontractor, requests in writing a change in the subcontractor and pays any increase in costs resulting from the change.

(b) The substitution is approved by the public body or its authorized representative. The substitution must be approved if the public body or its authorized representative determines that:

(1) The named subcontractor, after having a reasonable opportunity, fails or refuses to execute a written contract with the contractor which was offered to the named subcontractor with the same general terms that all other subcontractors on the project were offered;

(2) The named subcontractor files for bankruptcy or becomes insolvent;

(3) The named subcontractor fails or refuses to perform his or her subcontract within a reasonable time or is unable to furnish a performance bond and payment bond pursuant to <u>NRS</u> 339.025; or

(4) The named subcontractor is not properly licensed to provide that labor or portion of the work.

(c) If the public body awarding the contract is a governing body, the public body or its authorized representative, in awarding the contract pursuant to <u>NRS 338.1375</u> to <u>338.139</u>, inclusive:

(1) Applies such criteria set forth in <u>NRS 338.1377</u> as are appropriate for subcontractors and determines that the subcontractor does not meet that criteria; and

(2) Requests in writing a substitution of the subcontractor.

6. If a prime contractor substitutes a subcontractor for any subcontractor who is named in the bid without complying with the provisions of subsection 5, the prime contractor shall forfeit, as a penalty to the public body that awarded the contract, an amount equal to 1 percent of the total amount of the contract.

7. If a prime contractor, after the submission of the bid, substitutes a subcontractor to perform the work indicated pursuant to subsection 3 that the prime contractor would perform, the prime contractor shall forfeit as a penalty to the public body that awarded the contract, the lesser of, and excluding any amount of the contract that is attributable to change orders:

(a) An amount equal to 2.5 percent of the total amount of the contract; or

(b) An amount equal to 35 percent of the estimate by the engineer of the cost of the work the prime contractor indicated pursuant to subsection 3 that he or she would perform on the public work.

8. As used in this section:

(a) "First tier subcontractor" means a subcontractor who contracts directly with a prime contractor to provide labor, materials or services for a construction project.

(b) "General terms" means the terms and conditions of a contract that set the basic requirements for a public work and apply without regard to the particular trade or specialty of a subcontractor, but does not include any provision that controls or relates to the specific portion of the public work that will be completed by a subcontractor, including, without limitation, the materials to be used by the subcontractor or other details of the work to be performed by the subcontractor.

(Added to NRS by <u>1993, 2130;</u> A <u>2001, 573, 2268; 2003, 2130, 2430, 2500; 2005, 1803; 2011, 3688; 2013, 2970</u>)

In paragraph P "Subcontracting" of the Instructions to Bidders page ITB-8, second sentence of the paragraph clearly states that "The Bidder shall be bound by and comply with NRS. 338.141 . . . "

In paragraph D. "Interpretations and Addendum" in the Instructions to Bidders page ITB -2 the first sentence states "Bidder shall take no advantage of any apparent error or omission in this Bid Document." Therefore, the staff of Carson City has determined that the low bidder is in compliance with the requirements of the Bid Document.

Staff believes the above resolves your concerns, if not we will schedule the protest for the June 5, BOS meeting.

Dear Ms. Belt:

I represent Sierra Nevada Construction, Inc. ("SNC"). I am writing at this time with respect to the above-referenced project and to follow up on Marc Markwell's letter of May 21, 2014. Please let this serve as confirmation that SNC intends to proceed with a protest of any recommendation by Carson City to award this project to A & K Earth Movers or any award of the contract to A & K. As described in Mr. Markwell's letter, it is SNC's position that, by the very terms of Carson City's own specifications, A & K's bid on this Project was "deemed non-responsive" because A & K did not submit all of its required subcontractor lists. As such, it would be inappropriate and contrary to Nevada law to award a contract to a bidder whose bid was non-responsive.

In addition, please be advised that I am aware of your request for a bid protest bond for SNC to be able to proceed with a protest. I would respectfully submit that that request is improper. First, I would note that there is no requirement in the actual bid specifications for a protesting bidder to post a bond. NRS 338.142 permits the public agency to require a protester to file a protest bond "at the time the notice of protest is filed." However, because the bid specifications did not alert the bidders that a protest bond was required, a protester would not know, at the time the protest was filed, whether a bond was needed. Therefore, the statute permitting an agency to require a protest bond contemplates that any such requirement must be in the specifications or other documents to give the protesting company advanced notice that a bond will be required. It is my position that if the specifications do not require a protest bond, that requirement is waived.

Second, upon review of this matter, it is unclear to me whether Carson City has issued a Recommendation for Award to A & K Earth Movers. As you are aware, under NRS 338.142, a bid protest is triggered by the issuance of a Recommendation for Award. While I realize that Mr. Markwell's letter indicates that it is a protest pursuant to 338.142, as a technical matter, I do not believe a bidder can formally issue a protest until there has been a Recommendation for Award. To my knowledge, there has not been a Recommendation for Award issued by Carson City in this matter. However, if my information is correct, and if Carson City has issued a Recommendation for Award, please forward the same to me. Absent a Recommendation for Award, the request to post a bid protest bond, even if it was valid, would be premature.

Despite my objections to your present request for SNC to post a bid protest bond, please be advised that SNC stands ready, willing, and able to post a bid protest bond if necessary to proceed with its protest. Therefore, please contact me to discuss these issues so that I can make a determination as to whether a protest bond is required, whether it is required at this time, and when it would be due.

In conclusion, it appears from the facts that I am aware of at this time that it is clear and unequivocal that the bid of A & K Earth Movers was non-responsive and therefore must be rejected by Carson City. As such, please let this serve as a request that Carson City issue a Recommendation for Award of this Project to Sierra Nevada Construction.

In the meantime, please do not hesitate to contact me or have your attorney contact me to discuss these issues.

Dear Ms. Belt:

I am in receipt of your e-mail with attachments dated May 27, 2014 to Chris Spross of A & K Earth Movers. This e-mail indicates Carson City's intention to reject all bids on the abovereferenced project. This action, if taken, will be wholly inconsistent with the determination expressed previously to award A & K this work. Please be advised that such action, if taken by Carson City, will be contrary to Nevada law and to the clear detriment of A & K.

The email does not explain why Carson City believes that the job must be rebid. The attachment to the e-mail, the Agenda Report, states that "Staff believes its inclusion of sub-contract disclosure requirements in excess of the requirements of NRS 338.141 was a bid document error because the city does not possess legal authority under Dillon's Rule to exceed the bidding selection criteria and responsive bid requirements established by NRS Chapter 338."

A & K Earth Movers agrees that Carson City's bid documents required the inclusion of information not required by Chapter 338. This, however, does not invalidate A & K's bid which is full responsive to the requirements of NRS Chapter 338.

A & K is aware that by the letter dated May 21, 2014, Sierra Nevada Construction filed its Protest to A & K Earth Movers' bid. The Protest of SNC is based entirely upon a section of the bidding requirements by Carson City that Carson City now acknowledges it can not impose on projects by Nevada law. This does not change the fact that A & K is clearly the "responsive" bidder and is entitled to an award of the project.

I point out to you that A & K has completed a number of recent contracts with Carson City. In the bid proposals for these projects A & K did not provide the information which SNC contends must be provided for the bid to be responsive. Carson City accepted the bids of A & K, awarded the contracts to A & K, and accepted the work of A & K. SNC was another bidder on one or more of these projects without protest of the award to A & K. Furthermore, SNC was recently

awarded the Costco Intertie and Vista Grande Waterline project (copy of award attached), submitting a bid package which **did not** include the information upon which SNC is basing their Protest to A & K's bid (copy of submitted bid documents in question attached).

Lastly, A & K notes that in your Notice to Contractor's recently for Bid No. 1314-64 you have deleted any reference to the offending requirement.

A & K respectfully requests that Carson City re-evaluates it's determination to reject all bids and furthermore rejects SNC's Protest on the basis of no merit and award the subject project to A & K Earth Movers, Inc. as the lowest responsive bidder per the requirements of NRS 338.141.

Thank you for your consideration of this matter.

#### P. Subcontracting

The Bidder agrees that he/she will perform work totaling at least Fifty per cent (50%) of the Bid amount and will not subcontract work totaling more than Fifty per cent (50%) of the Bid amount.

The Bidder shall be bound by and comply with NRS 338.141 to limit the practice of shopping for Bids and shall provide a Subcontractors Listing with the submission of their Bid. The form must have the spaces filled in for each subcontractor who will be paid an amount exceeding five percent (5%) of the Bid amount. Within two (2) hours after the opening of Bids, the bidders who submitted the three lowest Bids must submit a list of names of each subcontractor who will provide labor or a portion of the Work or improvement to the Contractor for which he/she will be paid an amount exceeding one percent (1%) of the Bid amount or Fifty Thousand Dollars (\$50,000), whichever is greater. Within twenty-four (24) hours of the Bid opening the Bidder who submitted the lowest Bid must submit a list of all subcontractors who will perform any work on the Contract, including their name, license number and classification, items of work to be performed and anticipated amount of the subcontract. If a bidder fails to submit such lists within the required time, his/her Bid shall be deemed non-responsive.

The bidder shall verify prior to submitting their Bid that all subcontractors specified are properly licensed. Substitutions of subcontractors specified in the Bid shall comply with the requirements of NRS 338.141.

Bidder agrees that if awarded the Contract, he/she will assume responsibility for acts or omissions of subcontractors and of persons either directly or indirectly employed by them, as they are responsible for the acts or omissions of persons directly employed by the Bidder. Nothing contained in the Bid Document shall create any contractual relationship between any subcontractor and the City.

Each Contractor engaged on a public works project shall report to the Labor Commissioner the name and address of each Subcontractor whom he/she engages for work on the project within ten (10) days after the Subcontractor commences work on the contract.

Substitutions for subcontractors listed in the Bid Proposal shall comply with the requirements of NRS 338.141.

### Q. Site Information

Where investigations of surface or subsurface conditions have been made by the City, in respect to foundations or other structural design for design purposes only, said information is available only for the convenience of bidders but are not a part of the Bid Documents. The City, Construction Manager, and Design Consultant assume no responsibility whatsoever as to the sufficiency of borings, or of the log of test borings or other investigations, or tests, or of the interpretations thereof; there is no guarantee, warranty, or representation, expressed or implied, that the conditions indicated thereby, in fact, exist or are representative of those existing throughout the work. Such information available to bidders must satisfy themselves through their own investigations as to the surface and subsurface conditions to be encountered at the Site.

### IB.2. OPENING OF BIDS

All Bids received at the designated time and place that comply with these requirements will be opened, publicly read aloud at the date, time and place set forth in the Notice to Contractors. Bidders, their representatives, and all other interested persons may be present at the opening and reading of Bids.

Any Bids received after the date and time set for receiving and opening Bids, as set forth in the Notice to Contractors and any Addendum, will not be considered. Any such Bids will be returned unopened to the Bidder.

### A. Mistake in Bid

A request for withdrawal of a Bid due to a purported error shall not be considered unless it is given in writing to the Contract Administrator by the Bidder within forty-eight (48) hours after opening of the bid. Any such request shall contain a full explanation of any purported error and shall be supported by the original calculations on which the Bid was computed, together with a certification and notarization thereon that such calculation is the original as prepared by the Bidder or his/her agent.

BP.68 INSTRUCTIONS: for Subcontractors and General Contractors who self-perform in amounts exceeding five (5) percent of bld amount. This information must be submitted with your bld proposal. 





# **INSTRUCTIONS TO BIDDERS**

- 2. The submission of a Bld shall constitute an acknowledgment upon which the City may rely that the Bldder has thoroughly examined and is familiar with the Bld Documents. The Bldder shall in no way be relieved from any obligation with respect to its proposal or to the Contract. No claim for additional compensation will be allowed which is based upon a lack of knowledge of the Contract Documents.
- 3. The Bldder has inspected the site(s) of the Work and is satisfied, by personal examination or by other means, of the locations of the proposed Work, of the actual conditions, including subsurface conditions, of and at the site(s) of the Work. If, during the course of its examinations, a Bidder finds facts or conditions which appear to be in conflict with the letter or spirit of the Bid Documents before submitting his/her bid, the Bidder shall request the City, in writing, to provide additional information and explanation.
- 4. Submission of a Bid by a Bidder shall constitute conclusive evidence that the Bidder has relied on his/her own examination of (1) the site of the Work, (2) access to the site, (3) all other data and matters requisite to the fulfillment of the Work and on its own knowledge of existing facilities on and in the vicinity of the site of the Work to be constructed under the Contract, (4) the conditions to be encountered, (5) the character, quality and scope of the proposed Work, (6) the quality and quantity of the materials to be furnished, and (7) the requirements of the Bid, the Drawings and Specifications. The Bidder is aware that soil classifications do not represent any particular stability or drainability characteristics, and are aware that water table levels can vary.
- 5. The information provided by the City is not intended to be a substitute for, or a supplement to, the independent verification by the Bidder to the extent such independent investigation of site conditions is deemed necessary or desirable by the Bidder.
- 6. The Bidder, by signing the Bid Proposal, agrees that all material and workmanship on this Project shall meet or exceed OSHA standards and NOSHA standards.

Bidder must be duly qualified and possess the classification(s) of contractor's license stipulated by the City for this particular Work and issued by the Nevada State Contractor's Board. #### M. Fair Employment Practices

Pursuant to NRS 338.125, it is unlawful for any Contractor in connection with the performance of work under a contract with a public body, when payment of the contract price, or any part of such payment, is to be made from public money, to refuse to employ or to discharge from employment any person because of race, creed, color, national origin, sex, sexual preference, or age to discriminate against person with respect to hire, tenure, advancement, compensation or other terms, conditions, privileges of employment because of race, creed, color, national origin, sex, sexual preference or age.

#### N. Preferential Employment

Pursuant to NRS 338.130, Preferential Employment in Construction of Public Works, "In all cases where persons are employed in the construction of public works, preference shall be given, the qualifications of the applicants being equal: First: To honorably discharged Army, Navy, Air Force, Marine Corps or Coast Guard soldiers of the United States who are cltizens of the State of Nevada; Second: To cltizens of the State of Nevada". If the provisions of NRS 338.130 are not complied with by the Contractor, this Contract shall be void, and any failure or refusal to comply with any of the provision of NRS 338.130 shall render this Contract void.

#### O. Subcontracting

The Bidder agrees that he/she will perform work totaling at least Fifty per cent (50%) of the Bid amount and will not subcontract work totaling more than Fifty per cent (50%) of the Bid amount.

# **INSTRUCTIONS TO BIDDERS**

The Bidder shall be bound by and comply with NRS 338.141 to limit the practice of shopping for Bids and shall provide a Subcontractors Listing with the submission of their Bid. The form must have the spaces filled in for each subcontractor who will be paid an amount exceeding five percent (5%) of the Bid amount. The Bidder is also required to submit the DBE form at the time of Bid Submittal. The City, Construction Manager, and Design Consultant assume no responsibility whatsoever as to the sufficiency of borings, or of the log of test borings or other investigations, or tests, or of the interpretations thereof; there is no guarantee, warranty, or representation, expressed or implied, that the conditions indicated thereby, in fact, exist or are representative of those existing throughout the work. Such information available to bidders is not to be construed in any way as a waiver of the other provisions of this paragraph and bidders must satisfy themselves through their own investigations as to the surface and subsurface conditions to be encountered at the Site.

#### IB.2. OPENING OF BIDS
