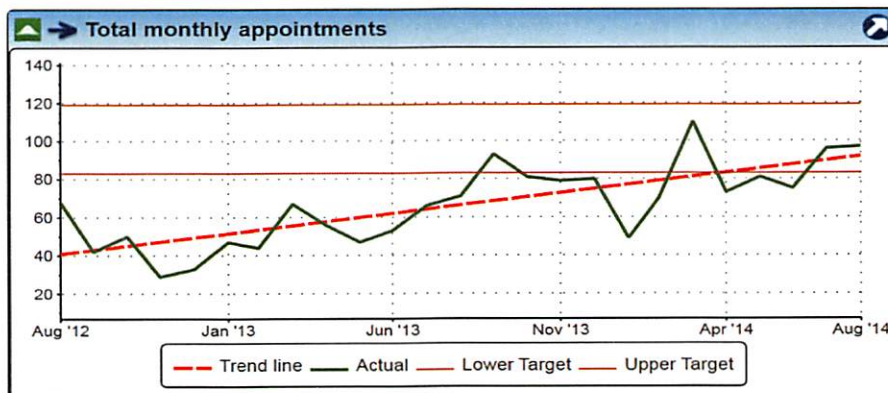

Tobacco Use Survey

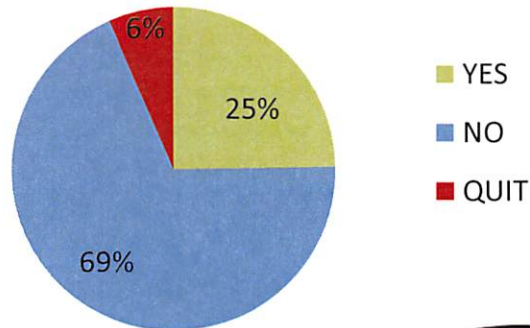

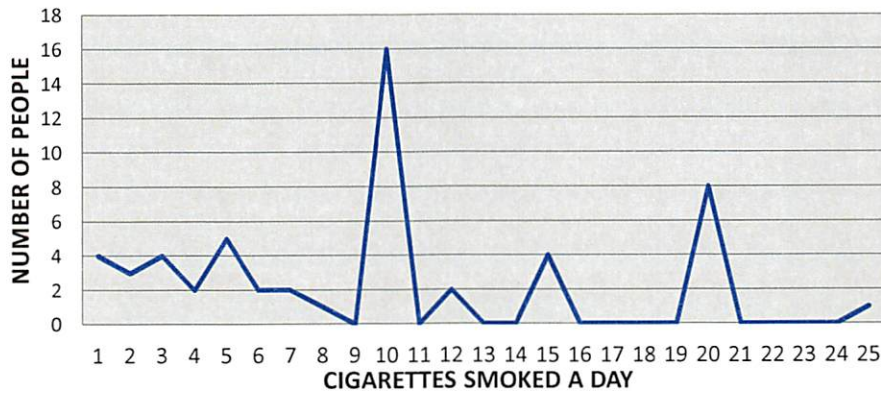
Do you smoke cigarettes?

If yes, how many per day?

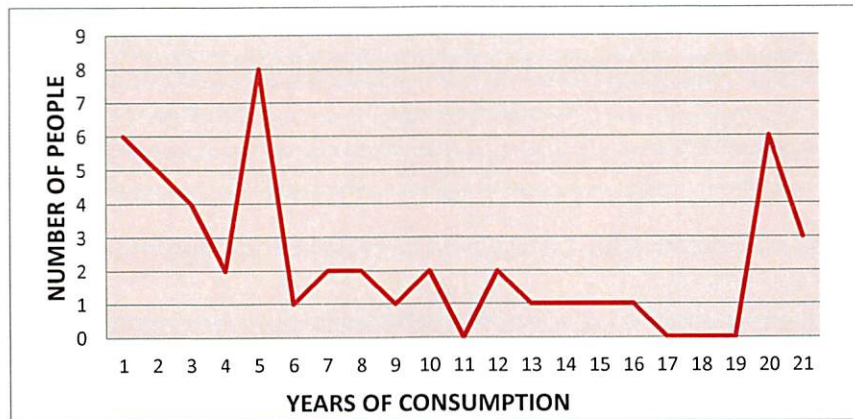

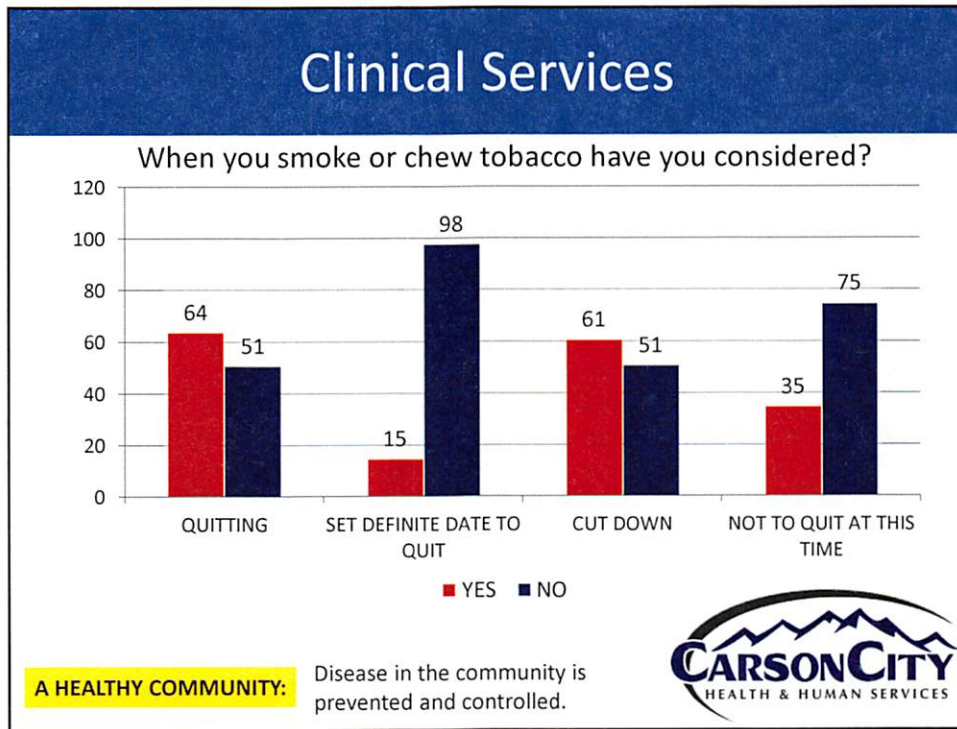

If yes, how many years?



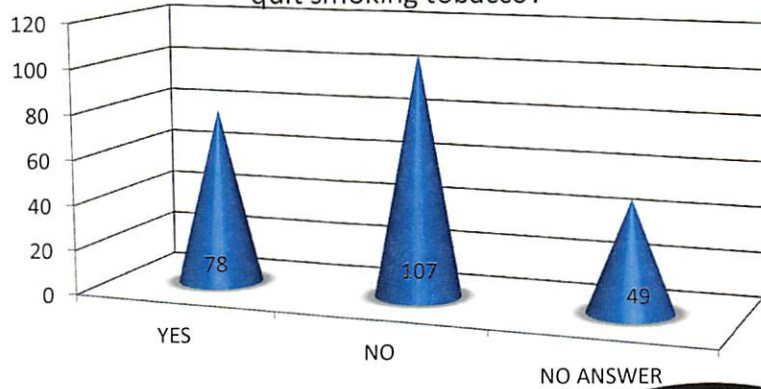

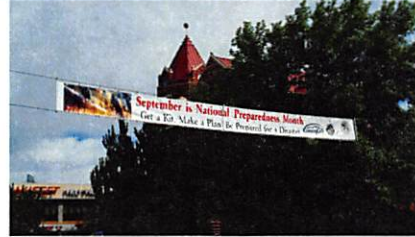

Chronic Disease Prevention and Health Promotion

AEGP (Abstinence)

- 68 total participants completed the program in Year 3 (October 1, 2013 – September 30, 2014)
- Sessions being scheduled for Year 4 with Silver State Charter School, Carson Valley Boys and Girls Club, and others



PREP (Comprehensive)

- 26 participants completed pilot project (May 1-Sept 30)
- 3 sessions held at Rite of Passage (2 for males only, 1 for females only)
- Granted a full award to continue programming for the grant cycle October 1, 2014 - September 30, 2015
