E. PUBLIC COMMENT

(6:04:06) – Glade Myler, Carson City resident on Apollo Drive, introduced himself and stated that the planes were flying "right over my home to get into the airport". He believed that there was no reason for airplanes to fly over Nye Lane and over his residence. Mr. Myler was under the impression that once the runway was extended, the planes would fly over the golf course instead of flying over his house. He also requested the item agendized for the next meeting. Chairperson Williams noted Mr. Myler's request and suggested that he send any new and additional information to Mr. Rowe. Member Poscic gave background on the FAA counseling the flight school regarding the issue. He also explained that the FAA would send its "Fast Team" on the first week of December to meet with all the pilots of the airport and instruct them on "the rules of the road, including traffic patterns, radio procedures, and safety procedures". Member Poscic advised Mr. Myler to attend that meeting.

1. DISCUSSION AND POSSIBLE ACTION REGARDING APPROVAL OF THE CARSON CITY AIRPORT AUTHORITY AUDIT FOR FY 2013/2014.

(6:10:06) – Beth Kohn-Cole, Kohn & Company, LLP, presented the Carson CityAirport Authority's FY 2013/2014 audit and a required board communication letter, which are incorporated into the record. She called the audit "clean" and reviewed her findings, also incorporated into the record.

(6:17:55) – Mr. Fitzgerald presented the Airport Engineer's Report which is incorporated into the record. He also noted that each of the projects was under budget. Based upon a question by Chairperson Williams, Mr. Fitzgerald believed that a meeting with the FAA was tentatively scheduled for December 6, 2014 in Carson City.

(6:22:04) – Member White requested additional information regarding the Main Apron Phase 1 construction spending, and was informed that the total project cost included the change orders that reflected the additional amounts spent. Discussion ensued regarding original budgeted amount versus final dollars spent on the project. Member White suggested including the percentage of the project overages.

I. AIRPORT MANAGER'S REPORT

(6:32:35) – Mr. Row presented the Airport Manager's Report noting that the Automated Weather Observing System (AWOS) computer had crashed and the cost of repair had been over \$500. He also advised of a response, incorporated into the record, he had received from the Bureau of Land Management (BLM) regarding the right-of-way application filed by the Authority for two solar-powered beacon lights in the Brunswick Canyon area. Mr. Rowe explained that the BLM would begin processing the application within six months, as they operated on a first come, first serve basis.
