- **1-4. CALL TO ORDER, ROLL CALL, INVOCATION, AND PLEDGE OF ALLEGIANCE** (8:30:23) Mayor *Pro Tem* Abowd called the meeting to order at 8:30 a.m. Mr. Glover called the roll; a quorum was present. Mayor *Pro Tem* Abowd advised that Mayor Crowell was being interviewed by CNBC regarding Tesla, and that he would be arriving later in the morning. First Christian Church Pastor Ken Haskins provided the invocation. At Mayor *Pro Tem* Abowd's request, Pastor Haskins led the pledge of allegiance.
- **5. PUBLIC COMMENT** (8:32:30) Mayor *Pro Tem* Abowd entertained public comment. (8:32:49) Fire Chief Stacey Giomi announced a ceremony scheduled for 9:00 a.m. on Thursday, September 11<sup>th</sup> at the 9/11 Memorial in Mills Park. He provided a status report on the relocation of the steel I-Beam from Ground Zero. Mayor *Pro Tem* Abowd entertained additional public comment; however, none was forthcoming.
- **6. POSSIBLE ACTION ON APPROVAL OF MINUTES May 15, 2014** (8:34:13) Supervisor Bonkowski moved to approve the minutes, with a correction to the approval date. Supervisor McKenna seconded the motion. Motion carried 4-0.
- 7. **POSSIBLE ACTION TO ADOPT THE AGENDA** (8:34:39) Mayor *Pro Tem* Abowd entertained modifications to the agenda and, when none were forthcoming, adopted the agenda, as published.
- 8. Judge John Tatro were unable to attend the meeting, but are fully supportive of the subject item. Ms. Cortes provided background information on this item, and reviewed the agenda materials.

Mr. Marano, Ms. Cortes, and Chief Fletcher responded to questions of clarification regarding general liability coverage, potential incidents, and the provisions of the agreement. Mayor *Pro Tem* Abowd entertained public comment and, when none was forthcoming, a motion. Supervisor McKenna thanked Judge Wilson and Judge Armstrong for their attendance. FIRE DEPARTMENT - POSSIBLE ACTION TO APPROVE A MEMORANDUM OF UNDERSTANDING, BETWEEN THE AMERICAN RED CROSS NORTHERN NEVADA CHAPTER AND CARSON CITY, FOR THE PURPOSE OF DEVELOPING A WORKING RELATIONSHIP TO PREPARE FOR AND RESPOND TO DISASTERS AND TO AUTHORIZE THE SIGNING OF A DOCUMENT ALLOWING FOR THE USE OF CITY FACILITIES AS EMERGENCY SHELTERS (8:42:00) - Mayor *Pro Tem* Abowd introduced this item, and Fire Chief Stacey Giomi reviewed the agenda materials. (8:43:03) American Red Cross Northern Nevada Chapter

Regional Chief Executive Officer Clara Andriola expressed appreciation for the opportunity to enter into a formal agreement with the City. She thanked Chief Giomi, Stacy Belt, and the community volunteers.

At Mayor *Pro Tem* Abowd's request, Chief Giomi reviewed shelter locations in the community. In response to a question, he clarified the City has agreements with the school district to use their facilities. "We can access that through this agreement. Then, [the American Red Cross] can go and develop those agreements with the school districts directly. We would use our facilities first in a disaster just because they're under our control and we don't have to go through another organization to get permission to use them." In response to a further question, Chief Giomi advised that the American Red Cross has stored equipment and materials in Carson City for a number of years. In addition, the City owns two disaster shelters as well. "So, between those three, we're able to open up a 150-bed shelter. Between our CERT volunteers, backed up by the Red Cross, we can get a shelter open in ... 60 to 75 minutes." Chief Giomi responded to additional questions regarding the American Red Cross Northern Nevada Chapter. Ms. Andriola offered additional information.

Mayor *Pro Tem* Abowd entertained public comment and, when none was forthcoming, a motion. Supervisor McKenna moved to approve a Memorandum of Understanding, between the American Red Cross Northern Nevada Chapter and Carson City, for the purpose of developing a working relationship to prepare for and respond to disasters and to authorize the signing of a document allowing for the use of City facilities as emergency shelters. Supervisor Bonkowski seconded the motion. Mayor *Pro Tem* Abowd entertained discussion on the motion and, when none was forthcoming, called for a vote.

HEALTH AND HUMAN SERVICES DEPARTMENT - POSSIBLE ACTION TO 11. INTRODUCE, ON FIRST READING, AN ORDINANCE AMENDING THE CARSON CITY MUNICIPAL CODE, TITLE 7, ANIMALS, CHAPTER 7.13, LICENSING AND REGULATIONS, TO AMEND SECTION 7.13.010, DEFINITIONS; TO AMEND SECTION 7.13.020, CARSON CITY ANIMAL SERVICES / POWERS: AND TO REPEAL AND RESERVE SECTION 7.13.040. Ms. Aaker and Mr. Marano responded to questions of clarification regarding fees and the effect of the ordinance.

Mayor *Pro Tem* Abowd entertained additional Board member questions or comments and, when none were forthcoming, public comment. (8:55:39) Carson Animal Services Initiative ("CASI") Founder Lisa Schuette expressed appreciation for the proposed ordinance, and discussed the benefits of contracting with the Nevada Humane Society. Supervisor McKenna thanked Ms. Schuette and CASI for their fundraising efforts and for "bringing the matter of animals to the attention of Carson City." Ms. Schuette acknowledged the mission of CASI to continue to support the animal shelter even after it is constructed. She announced a 5K-9 race fundraiser scheduled to begin at 9:00 a.m. on September 20<sup>th</sup> at Riverview Park, and a Pooch Plunge scheduled on September 27<sup>th</sup>. She discussed CASI's grant writing efforts, and reviewed various and ongoing activities. Mayor *Pro Tem* Abowd thanked Ms. Schuette for her "energy and dedication."

Mayor *Pro Tem* Abowd entertained additional public comment. (8:59:29) Ward 1 Supervisor Candidate Lisa Helget reviewed suggested revisions to the language of the proposed ordinance. (9:06:47) At Mr. Marano's request, Nevada Humane Society CEO Kevin Ryan reviewed the contractual provisions, between the Nevada Humane Society and Washoe County.

Following extensive discussion and in response to a question, Mr. Marano reviewed the timeline associated with the subject bill and the contract between the City and the Nevada Humane Society. He advised of "no objections, to date, that would warrant going through a delay process and ... any type of public forum. We have already done considerable outreach." He advised of having fielded a number of questions and of his intent to continue outreach. He reiterated there had not been any type of opposition to the proposed bill.

Mayor Pro Tem Abowd entertained a motion. Supervisor McKenna moved to introduce, on first reading, Bill No. 111, an ordinance amending the Carson City Municipal Code, Title 7, Animals, Chapter 7.13, Licensing and Regulations, to amend Section 7.13.010, Definitions; to amend Section 7.13.020, Carson City Animal Services / Powers; and to repeal and reserve Section 7.13.040, Collections/Disbursements/Fee Schedule; to further provide for the contract authority of the Board of Supervisors to contract out animal services with a society for the prevention of cruelty to animals incorporated under Nevada Revised Statutes Chapter 574 for their operation, direction, supervision, regulation, policing, and enforcement of this Chapter, and any other powers that the City deems necessary for the administration of this provision, as a private, non-profit entity, pursuant to a contract and/or fee schedule approved by the Carson City Board of Supervisors, and other matters properly related thereto. Supervisor Bonkowski seconded the motion for purposes of discussion. Supervisor McKenna explained the purpose for the additional verbiage, and expressed the belief that the contract is the proper document to deal with the matters and the powers that the Board provides to a contractor. He acknowledged the validity of the concerns expressed and the discussion which took place at this meeting, but expressed the opinion that "they are contract matters." Supervisor Bonkowski agreed, and noted that any further objection to the provisions of the ordinance can be brought forward prior to second reading. In response to a question, Supervisor McKenna provided additional clarification of the purpose for the proposed additional verbiage. Discussion followed, and Mayor *Pro Tem* Abowd called for a vote on the pending motion.

12. PARKS AND RECREATION DEPARTMENT - POSSIBLE ACTION TO AUTHORIZE STAFF AND THE MAYOR TO EXECUTE DOCUMENTS TOWARDS THE FEE TITLE ACQUISITION OF APPROXIMATELY 28,424 SQUARE FEET FROM THE ARRAIZ FAMILY 1993 TRUST, LOCATED AT LOMPA LANE, A PORTION OF APN 010-041-67, FOR THE DEVELOPMENT OF THE FREEWAY MULTI-USE PATHWAY (9:50:02) - Mayor *Pro Tem* Abowd introduced this item. Mayor Crowell disclosed that his law firm is retained by the Arraiz Family 1993 Trust, and that he would abstain from participation in this item. He requested Mayor *Pro Tem* Abowd to continue chairing the meeting and stepped away from the dais.

Open Space / Property Manager Juan Guzman reviewed the agenda materials. He and Transportation Manager Patrick Pittenger responded to questions regarding associated costs and fees, the funding mechanism, design of the linear park path, and ownership and maintenance of the property. Parks and Recreation Department Director Roger Moellendorf provided additional clarification regarding maintenance of the path. In response to a further question, Mr. Pittenger advised that the \$10,000 to be allocated from the Regional Transportation Commission will have no direct impact on street maintenance. He noted that the \$10,000 allocation leverages "hundreds of thousands of dollars in federal funds."

Mayor *Pro Tem* Abowd entertained additional Board member questions or comments and, when none were forthcoming, public comment. (10:02:09) Muscle Powered President Donna Inversin noted the importance of the subject section of path as "an important connection to our overall ... trail system ..." She discussed frequent use of the freeway multi-use path.

(10:03:40) In consideration of Mr. Guzman's impending retirement, John Wagner commended his City service. The Board members, City staff, and citizens present applauded.

Mayor *Pro Tem* Abowd entertained additional public comment and, when none was forthcoming, offered Mr. Guzman the opportunity to comment. Mr. Guzman expressed appreciation for the opportunity to have worked in Carson City, and for the Board's confidence in acquiring open space for the community. Supervisor McKenna thanked Mr. Guzman for "his hard work and his vision," noting the worthy investment in open space. He commended Mr. Guzman's efforts in acquiring important properties and "making open space what it is at an affordable amount."

Mayor *Pro Tem* Abowd entertained a motion. Supervisor Bonkowski moved to authorize staff and the Mayor to execute documents towards the fee title acquisition of approximately 28,424 square feet from the Arraiz Family 1993 Trust, located at Lompa Lane, a portion of APN 10-041-67, for the development of the Freeway Multi-Use Pathway, inclusive of the changes detailed by Mr. Guzman

Mayor Crowell entertained public comment. (10:23:13) Ward 3 Supervisor Candidate Lori Bagwell inquired as to whether the bond will allow for a decrease in water rates. Mr. Providenti acknowledged that the bond will help, but he doesn't anticipate any offset to the water rates.
