The employee is responsible for the supervision of 8 individuals plus volunteers, tracks departmental budgets, audits payroll, audits and tracks all grants, assumes the duties of Director when the Director is unavailable, plans, monitors and oversees the departmental office work flow, supervises the posting of departmental meeting notifications and the assembling and distribution of agendas.
